(a)Other Disposal - Díuscairt Eile

Proposed by Cllr T. Maher, Seconded by Cllr. M.H. Cavanagh and agreed "That Kilkenny County Council, in accordance with Section 183 of the Local Government Act, 2001, to dispose of lands, as indicated on the attached map, at Ballytarsna, Cashel, Co. (c) Community and Enterprise - Fiontar agus Pobail

John McCormack advised members that it is proposed that the Dublin Declaration (Declaration of Age Friendly Cities and Communities) be signed by Kilkenny County Council. The resolution as proposed would facilitate the Chairman signing on behalf of the members of the Council. The Declaration would be signed as part of the WHO International Conference in Dublin on the 28th September, 2011.

It was proposed by Cllr. J. Coonan, Seconded by Cllr. J. Brennan and agreed that "Kilkenny County Council and on behalf of the members of Kilkenny County Council certify that we in Kilkenny wish to formally endorse the "Dublin Declaration".

Cllr. M. Noonan called on the Government to ratify the Madrid International Plan of Action on Ageing in Ireland.

(d) Roads - Boithre

(i) National Salt Allocations and Winter Maintenance Allocation

Mr. John Mulholland advised members that an additional allocation of €40,000 has been received for winter maintenance from the Dept. of Transport. 2,750 tonnes of salt is allocated to Kilkenny for national roads and 670 tonnes for Regional and Local Roads. Kilkenny County Council will have access to approximately 4,000 tonnes of salt for the upcoming winter period.

(ii)& River Duiske Dredging Allocation and Preliminary Flood Risk

(iii) Assessment

Mr. John Mulholland advised members that a grant allocation of €36,000 has been received from the Office of Public Works for removal of silt and debris from the Duiske Stream at Graiguenamanagh. The work will be carried out in 2012. The Preliminary Flood Risk Assessment is currently on public display. Details are outlined in the report circulated to members with the agenda. Kilkenny County Council will be submitting a formal response to the Preliminary Flood Risk Assessment. Cllr. Prendergast welcomed the allocation; however it is not sufficient to solve the problems in the Duiske River. He requested information/proposals for the River Barrow.

Contributions were also received from Cllr. S. Treacy, Cllr. M. O'Brien, Cllr. P. Millea, Cllr. P. Cuddihy in relation to requesting additional funds, status of application for funds for River Barrow and delays in getting the works done.

Mr. John Mulholland advised that an application for funding for the River Barrow has been made and the Council are awaiting a decision. The Council staff liaise continuously with O.P.W to source funding for works in all locations. Works will be carried out at the appropriate time of year following a tender process.

It was proposed by Cllr. M. O'Brien and Seconded by Cllr. T. Prendergast and agreed "That Kilkenny County Council write to Office of Public Works for an allocation for the Barrow Flood Relief Scheme."

(iv) Tower Road Junction on the N24

Mr. John Mulholland outlined the proposals for an over bridge over the N24 and associated works on the N24. Details are provided in the report circulated to members and approval of the members is required to proceed with the advertisement of this proposal in accordance with Part 8 of the Planning and Development Acts.

It was proposed by Cllr. T. Maher, Seconded by Cllr. M. Brett and agreed that "Kilkenny County Council, hereby approves to proceed with public consultation in respect of the proposed Tower Road and Ink Bottle Junction Improvement Scheme on the N24 National Secondary Road in accordance with Part 8, Article 81 of the

Planning & Development Regulations, 2000-2010 and the Planning & Development Acts, 2000-2010."

- (v) Proposed by Cllr. M. Shortall, Seconded by Cllr. C. Connery and agreed That "That Kilkenny County Council hereby approves of the proposal to publish Notice of Intention to extinguish the public right-of-way at County Road no: Local Access Road adjacent to LP3434 in the townland of Rockshire Road, Mountsion, Ferrybank, Co. Kilkenny."
- (vi) Proposed by Cllr. B. Ireland, Seconded by Cllr. T. Maher and Agreed that "Kilkenny County Council hereby approves of the proposal to publish notice of intention to Extinguish Public Right-of-Way under Section 73 of the Roads Act, 1993 at County Road No: LT.26301 at Rathaleek, Cuffesgrange, Co. Kilkenny."
- (vii) Proposed by Cllr. M.Shortall, Seconded by Cllr, J. Brennan and agreed that "Kilkenny County Council take the estate in charge and roads to be declared public roads and entered into the Roads Schedule of Kilkenny County Council at 3 houses at Donaguile Court, Donaguile, Castlecomer, Co. Kilkenny."
- (viii) Proposed by Cllr. T. Prendergast, Seconded by Cllr. S. Treacy and agreed that "Kilkenny County Council to initiate proceedings for the formal Taking-in-Charge of Cottage Gardens, Graiguenamanagh, Co.Kilkenny."

(e) Finance - Airgeadais

(i) Economic Update

Mr. Crockett, County Manager circulated an updated written report on the Economic Development Policy. He outlined to the members the current status on projects on specific initiatives that have been undertaken in the five sectors.

Contributions were received from Cllr. M. Shortall, Cllr. M. O'Brien, Cllr. M. Noonan, Cllr. P. Crowley, Cllr. P. Cuddihy, Cllr. J. Brennan, Cllr. P. Dunphy, Cllr. T. Breathnach, and Cllr. T. Maher. Members complimented the Manager and staff on the initiatives being taken and urge that the staff continue to highlight the issues raised. Issues raised related to the need to re-activate the Economic Subgroup under the County Development Board, the need for companies to link with the Kilkenny Invest website, development of Technological University in the South East, the promotion of Belview as a strategic area for job creation, expansion of the milk supply when the quotas will be lifted in the next few years.

Mr. Crockett responded to all queries raised by members and thanked the members for the priority given to economic development and the need to continue to develop the different sectors despite the economic downturn. There has been support given by the major players and small to medium enterprises into the various sectors such as agri-food, education, etc. to the various initiatives outlined.

Cllr. P. Cuddihy thanked the County Manager for all his work and the staff for their efforts in promoting Kilkenny for future investment. He also congratulated Waterford City Council for their contribution to the success of the Tall Ships Festival.

(f) Planning - Pleanail

(i) <u>Manager's Report on Submissions to the Material Alteration to Proposed Variation 2 to the County Development Plan.</u>

Mr. Denis Malone outlined to the members details of the Proposed Variation 2 to the Kilkenny County Development Plan 2008-2014. The Manager's report on submissions to the Material Alteration dated 12th September, 2011 has been circulated to all the members. The material alteration went on public display in August 2011. Submissions were received following the public display and the report as circulated details these submissions, the response and the Manager's recommendation.

Cllr. T. Breathnach proposed an amendment to submission PMA7 – Manager's recommendation. Part 3 – as following:
"Amend the Action in Section 5.8.5.2 as follows: - "To seek to undertake an integrated retail study". Cllr. A.M. Irish seconded the amendment. Contributions were received from Cllr. C. Long, Cllr. M. Noonan, Cllr. F. Doherty, Cllr. P. Dunphy, Cllr. E. Aylward in relation to the variation. Members stated that the shopping centre as developed in Ferrybank needs to be opened, the joint retail strategy is long awaited and there needs to be progress made between the local authorities. Ferrybank Shopping Centre will complement and supplement existing business in the greater city area as Ardkeen and Lisduggan has done. Cllr. M. Noonan expressed concerns at the development of this scale in Ferrybank as it will be detrimental to other businesses, it may create jobs in Ferrybank but there will be job losses in other areas of the city.

Mr. Denis Malone responded to the issues raised by the members and stated that the reasons for the change is to align the Ferrybank Local Area Plan with the County Development Plan, it is important to have consistency in both plans. The Ferrybank Area does need a centre similar to that available in Lisduggan.

It was proposed by Cllr. M. O'Brien, Seconded by Cllr. P. Dunphy and agreed that "Kilkenny County Council, having considered the proposal to make Variation 2 to the Kilkenny County Development Plan 2008-2014

under Section 13 of the Planning & Development Acts 2000-2010, having considered the County Manager's Report as circulated on the 12th July 2011 prepared in accordance with Section 13 (4) of the above Acts on the written submissions to the Proposed Variation, and having considered that the Proposed Variation should be altered in accordance with our decision made at the meeting of Kilkenny County Council held on 18th July, 2011, having published the proposed modifications on the 10th of August, 2011, having considered the County Manager's Report of the 12th September 2011 on the submissions to the proposed modifications at the meeting of Kilkenny County Council held on the 19th September 2011, do hereby consider that the Kilkenny County Development Plan should be varied in accordance with the procedures under Section 13(6) of the Planning & Development Act 2000 as amended and with our decision made at a meeting of Kilkenny County Council held on the 19th September 2011". (The Variation being the proposal published as the "Proposed Variation" as modified by resolution of the Council 18th July 2011 (and modified by any resolution dated 19th September 2011).

(g) Water Services – Seirbhísí Uisce

(i) Water Conservation Project Update

Mr. Michael Murphy, Senior Executive Engineer made a presentation to the members on the Water Conservation Project. He advised members that water production in County Kilkenny has been reduced by 18% since January 2009 due to the Water Conservation Project. Funding is in place to continue with the Active Leakage Control Project, and replacement of 10.1km of old watermains with persistent high leakage. A total of €7m has been allocated to County Kilkenny since the Water Conservation Project commenced in March 2007.

Contributions were received from Cllr. M. O'Brien, Cllr. M. Brett, Cllr. S. Treacy, Cllr. J. Brennan, Cllr. J. Coonan, Cllr. T. Breathnach. Members raised issues in relation to water supply and quality of supply in a number of locations – Inistioge, Castlecomer, Clogh, metering of supply and rainwater conservation.

Mr. Michael Murphy responded to all queries raised and stated that there will always be a percentage of unaccounted water. The Council can only repair public mains. Private mains are the responsibility of the houseowner/property owner.

Cllr. P. Cuddihy thanked the water services quality team for achieving 100% compliance in Water Quality Micro-biological results in 2010 for all public water schemes.

Cllr. P. Cuddihy also congratulated the E.P.A Regional Laboratory in Kilkenny in achieving I.S.O accreditation within the last few weeks.

(ii) <u>Part VIII</u> - <u>Report and Recommendation for Coon Wastewater</u> Treatment Plant

It was proposed by Cllr. J. Brennan, Seconded by Cllr. M. Shortall and agreed that "In accordance with Article 179 of the Local Government (Planning and Development) Acts 2000 - 2010 as amended and Part 8 of the Planning and Development Regulations 2001 – 2010, as amended, Kilkenny County Council hereby approves the Part 8 recommendation subject to the conditions set out in the recommendation and gives notice of its intention to construct a new Waste Water Treatment Plant at Coan West, Coan, Co Kilkenny."

Cllr. J. Brennan thanked the staff for progressing the project to Part 8 and requesting clarification on funding for the works. Cllr. M. Shortall stated that proposals for improvements in Freshford and Castlecomer need to be progressed and questioned whether they could be funded through small schemes allocation.

Mr. P. O'Neill responded that application for funding for Coan Wastewater Treatment Plant has been made and work is ongoing in preparing proposals for other schemes in the County.

(h) <u>Joint Waste Management Plan</u>

Mr. P. O'Neill advised members that Section 85 Agreement is required between Kilkenny County Council and the lead authority, South Tipperary to develop and implement the Joint Waste Management Plan for the South East Region. An evaluation of the Plan will be completed by 31st December, 2012.

It was proposed by Cllr. M. Fitzpatrick, Seconded by Cllr. M. Noonan and agreed that "That South Tipperary County Council shall enter into an agreement [in the form annexed hereto] with Waterford County Council, Carlow County Council, Waterford City Council, Kilkenny County Council and Wexford County Council pursuant to Section 85 of the Local Government Act 2001, for the purposes of exercising the powers, functions and duties of those Councils in connection with the evaluation, and, if appropriate, the revision or replacement of the Joint Waste Management Plan made by Carlow, Kilkenny, South Tipperary and Wexford County Councils and Waterford City Council on 01 June 2006 and by Waterford County Council on 02 June 2006 (hereinafter called the "Waste Management Plan") and also for the purpose of implementing the Waste Management Plan following upon such evaluation, revision or replacement (as the case may be) and for that purpose to exercise all of the powers, functions and duties of the said Councils under the following Acts, and any Regulations made thereunder:

1. The Waste Management Act 1996

- 2. The Waste Management (Amendment) Act 2001
- 3. The Local Government Act 2001
- 4. The State Authorities (Public Private Partnership Arrangements)
 Act 2002
- 5. The Housing Act 1966
- 6. The Planning and Development Acts 2000-2006
- 7. The Protection of the Environment Act 2003

whether within the administrative area of Waterford County Council, or the administrative areas of any of the other aforementioned Councils. Without prejudice to the generality of the foregoing, South Tipperary County Council may do all or any of the following on behalf of the aforementioned Councils for the purposes of the evaluation, revision or replacement (as the case may be) and implementation of the Waste Management Plan including but not limited to:

- (a) The publication of all notices required to be published in connection with the evaluation, revision or replacement (as the case may be) and implementation of the said Plan
- (b) The receipt, evaluation, revision or replacement (as the case may be) and consideration of all representations made in connection with the same
- (c) The formulation and publication of any proposed amendments, revisions (or replacements) to the said Plan
- (d) All other matters and things necessary and incidental to the evaluation, revision or replacement (as the case may be) and implementation of the said Plan (but excluding the making of any new or amended Plan arising out of the aforementioned review)
- (e) The compliance with all statutory procedures necessary for the evaluation, revision and replacement (as the case may be) and implementation of the Plan
- (f) The undertaking of all surveys or studies required to be undertaken in connection with the same
- (g) The appointment of all consultants necessary for the evaluation, revision or replacement (as the case may be) and implementation of the Plan
- (h) The appointment of all contractors necessary for the implementation of the Plan

- (i) The entry into all necessary contracts for the collection, recovery, reuse, transfer, sale or disposal of waste within the administrative area of all of the said Councils
- (j) The entry into such Public Private Partnership arrangements as are appropriate, desirable or necessary for the implementation of the Plan
- (k) The engagement in such promotions, communications and public consultations as are necessary or desirable
- (l) The entry into all such contracts as may be required for the provision of all services and facilities necessary to implement the Plan
- (m) The carrying out of all technical, financial, legal and other assessments as required
- (n) The carrying out or the arrangement to carry out all administrative acts required in connection with the evaluation, revision or replacement (as the case may be) and implementation of the Plan
- (o) The entry into all appropriate arrangements with Government Departments, the National Development Finance Agency or other State Authorities as necessary in connection with the implementation of the Plan
- (p) The undertaking of all procedures required by law to be undertaken in connection with the procurement of any goods and services required in connection with any of the foregoing
- (q) All other matters and things necessary and incidental to the implementation of the Plan

and for all of the aforesaid purposes reference to the Plan shall be deemed to include any Waste Management Plan made by all of the aforementioned Local Authorities (including this Council) in replacement or variation of the Plan".

Presentation by Irish Sports Council

At this stage, Cllr. P. Cuddihy welcomed Mr. John Treacy, Irish Sports Council and Nicola Keeshan, Kilkenny Sports Partnership to the meeting.

Ms. Keeshan made a presentation to the members on the works of the Kilkenny Sports Partnership and the projects undertaken by them to date. A copy of the presentation was circulated to members.

Contributions were received from Cllr M. Fitzpatrick, Cllr. C. Long, Cllr. P. Crowley, Cllr C. Connery, Cllr M. Noonan, Cllr. M. Shortall, Cllr M. Brett. Members complimented Nicola Keeshan and staff of Kilkenny Sports Partnership for their valuable work in the communities across the City and County.

Queries were raised by members in relation to programme of activities for certain age groups, funding for the programme, the need to emphasise the value of the projects for the benefit of people's health, marketing of the various sports activities and availability of information.
