Community Facility Scheme

Mr. Michael Delahunty referred to Report dated 17th July, 2017 circulated to members. He outlined the terms of this new Scheme and the funding available under this Scheme. Full details are included in the Report circulated.

He advised that 61 applications have been received through an open advertisement which was widely circulated. A sub-group of the LCDC evaluated the applications and reported to the LCDC. The LCDC has considered the applications and is recommending the award of grants as outlined in the schedules circulated.

A total funding of €121,000 was requested. However, the allocation for Kilkenny is €64,500 and this amount has been allocated as per the schedules to all eligible applicants. A number of applications were considered ineligible.

Mr. Delahunty responded to members gueries.

Mr. Delahunty advised that each Municipal District is required to approve the recommendations for their Districts.
