- 2. The section of Local Secondary Road L6696 in the Townlands of Brownstown and Parkmore, between the lines 2 2 and 2A 2A, for a distance of 76m.
- 3. The section of Local Primary Road L2630 in the Townlands of Parkmore and Derdimus, between the lines 3 3 and 3A 3A, for a distance of 41m.
- 4. The section of Local Primary Road L2630 in the Townlands of Raheenapisha and Goslingstown, between the lines 4 4 and 4A and 4A, for a distance of 262m.
- 5. The section of National Secondary Road N76 (Callan Road) in the Townlands of Derdimus, Goslingstown, Shellumsrath and Archersleas, between the lines 5 5 and 5A 5A, for a distance of 1020m.
- 6. The section of National Secondary Road N76 (Callan Road) in the Townlands of Shellumsrath and Archersleas, between the lines 6 6 and 6A 6A, for a distance of 620m.

The order will also authorise the local authority to extinguish the public rights of way described in Part II of the Schedule hereto, by order made by them after they have acquired the land, where the said public rights of way are over the land so acquired or any part thereof, or over adjacent to or associated with the land so acquired or any part thereof. The Board may at its discretion, decide not to confirm the compulsory purchase order in respect of the land referred to in the Schedule if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and not withdrawn or if there is an objection to the extinguishment of a public right of way and not withdrawn until it has caused to be held an oral hearing in respect of the compulsory purchase order and until it has considered the objection and the report of the person who held the oral hearing.
