Re: Project Reporting System (PRS) for National/Regional and Local Road Schemes **SCHEDULE OF PAYMENT RUNS - 2014**

Dear Director / Town Clerk / Senior Engineer,

I wish to advise you of the Project Reporting System (PRS) Schedule of Payment Runs for 2014.

As you may be aware, the PRS is the facility for the recoupment of expenditure incurred against NRA Grant allocations. There are a number of payment runs per month for National Road Grant Claims and one payment run per month for Regional and Local Road Grant Claims.

In order to ensure the continued prompt and efficient processing of claims by the Authority, it is necessary to implement the attached arrangements for the 2014 calendar year.

All claims submitted to the NRA are deemed to be eligible (as defined by the Chargeability of Expenditure to National Road Grants – January 2013) on the basis of the certification of the claim, by the Director of Finance or a notified nominee (ref. NRA Circular 06/2011).

Claims submitted by local authorities, if approved by the NRA Inspector, will be processed in the next available payment run. It is, therefore, the responsibility of local authority Directors of Finance to ensure that claims are submitted on time for inclusion in the required payment run. Claims must be submitted to the NRA before 12.30pm on the Friday prior to a payment run.

It is the responsibility of each Local Authority / Town and Borough Council to ensure compliance with the Government Decision of S29296 of 2 March 2011 on Prompt Payments.

Your co-operation in the adoption and implementation of the arrangements indicated would, therefore, be appreciated.

Local authorities should ensure that payment arrangements with contractors are structured around the December payment run.
