1. Introduction

It addresses the submissions received during the 4 week public consultation period, from the 31st January 2019 to the 28th of February 2019, in relation to the Proposed Material Alterations to the Draft Thomastown LAP.

- may be made where it is minor in nature and therefore not likely to have significant effects on the environment or adversely affect the integrity of a European site,
- Shall not be made where it refers to - an increase in the area of land zoned for any purpose, or an addition to or deletion from the record of protected structures.

A Screening Report for Strategic Environmental Assessment and a Screening report for Appropriate Assessment accompany the Proposed Material Alterations to the Draft LAP.

5. Summary of Recommendations of the Chief Executive
