- tell them your symptoms and the details of your situation







### ROADS

We are delivering an ambitious road works scheme in 2020 of €29 million. This is made up of €11 million on National and €18 million on non-national road network.

#### NATIONAL ROADS

##### Kilkenny Major Schemes:

##### N25 Glenmore to Waterford Scheme

The design of this proposed scheme is within the concluding stage of Phase 2 - Option Selection. The scheme links the Glenmore and Luffany roundabouts and is intended to provide route consistency between the recently completed New Ross By-Pass and the Waterford By-Pass.

##### N24 Waterford to Cahir Scheme

In July 2020, Kilkenny County Council as the lead authority announced the appointment of Ove Arup and Partners Ireland Ltd. to bring the N24 Waterford to Cahir Road Scheme through planning and design. The appointment is a major boost for Counties Kilkenny & Tipperary directly as the project passes through both these local authority areas, with the wider south east region seeing the positive benefits that the scheme will provide.

##### Kilkenny Minor Schemes:

A number of minor schemes are progressing through various stages in conjunction with TII on the national road network.

##### N24 Tower Road:

Planning approval for the proposed scheme was secured in 2019. Approval of the Compulsory Purchase Order for the scheme was given by An Bord Pleanála on the 5<sup>th</sup> August 2020. We are presently undertaking the administrative procedures necessary to give effect to that Confirmation Order. It is expected that construction will commence in 2021.

##### N77 Ballyragget to Ballynaslee:

The proposed road will be a single carriageway road extending 2.44km from a point 250m south of the main Glanbia entrance until it joins the recently completed Ballynaslee Road Improvement Scheme (2014). A planning application under 177AE and a Compulsory Purchase Order application will be submitted to An Bord Pleanála in the coming weeks.

##### N24 Carrick Road:

The section of N24 proposed to be improved is rural in nature and located immediately North West of the village of Mooncoin in County Kilkenny. The overall length of the scheme is 1.9km. We are currently preparing the necessary documentation to make an application to An Bord Pleanála for approval under 177AE and also Compulsory Purchase Order approval for the scheme. It is expected that the application will be made before year end.

#### PAVEMENT IMPROVEMENTS

##### N76 Pavement Improvement Scheme (Cuffesgrange and Tullamaine Section.)

Road Resurfacing Works on the N76 from Cuffesgrange to Callan are being undertaken by Priority Construction Ltd on behalf of Kilkenny County Council. The works involved strengthening and resurfacing of 1.3km at Cuffesgrange and 3.5km from Ballymack to Callan and also includes road edge improvements on drainage and kerbing of junctions. The works on site commenced on 20<sup>th</sup> July and will be completed by the end of Sept 2020.

#### NON-NATIONAL ROADS

We are continuing with our work on the non-national road network. The bulk of the work is on restoration improvement and restoration maintenance which is over 90% complete. All this work is carried out by our own crews through the Municipal Districts and the Machinery Yard.

#### ENVIRONMENT

##### Trends Since Covid-19

Since restrictions were introduced in mid-March to combat the spread of Covid-19 the Environment Section has seen a significant increase in activity across a number of key headings listed hereunder: -

##### Environmental Complaints

The number of complaints logged and investigated by the Environment staff since mid-March up to the end of August has increased by 30% when compared to the same period for 2019, with 599 complaints received. The nature of the

complaints range from littering and illegal dumping through to issues relating to water quality and noise to abandoned cars and illegal burning. However, the majority of complaints (at 56%) relate to littering and illegal dumping. All complaints are logged on our CRM System (Customer Relations Management System) given a unique ID No. and assigned to the appropriate staff member for investigation. To combat the increasing incidence of littering and illegal dumping and to raise awareness of the issue, the Environment Section has run numerous media campaigns. Our Enforcement Officers have also been very active on the ground with over 185 fines issued and 26 actions taken under the Litter Pollution Act and Waste Management legislation this year to-date.

There will be an incentivised bulky furniture disposal event at both the Dunmore and Granny civic amenity sites in September. These events are being funded through the Anti-dumping Initiative Programme and it is hoped same will reduce illegal dumping of such items across the county.

##### Bring Banks

The Council provides and manages 46 Bring Banks across the city and county. Since mid-March activity at these facilities has increased by 51% with a total of 1,338 tons of glass, tin and aluminium collected representing an additional 451 tonnes when compared with the same period last year. Environment staff are continuing to work very closely with our Service Providers to ensure the level of service is in keeping with the demand.

##### Dunmore Civic Amenity Site

Activity at the Dunmore Civic Amenity Site has also increased with customer numbers up 13% since mid-March when compared to 2019 figures, with over 50,000 customers availing of the facility this year to-date. The tonnage of waste and recycling material collected at the facility has also increased by 12% since mid-March, with over 3,150 tonnes collected.

### Kilkenny Recreational and Biodiversity Park

Following a competitive tendering process, design consultants, Mitchell + Associates, were recently appointed to advance the development of the repurposing of the closed 17acre former landfill site at Dunmore. This is an exciting project for Kilkenny and our consultants are developing an inventive proposal that will attract regional and national attention, while putting forward a wide range of offerings to the public. An emphasis is being placed on recreational uses such as walking, running, cycling, dog friendly spaces, orienteering, along with educational offerings in terms of flora/ fauna identification and biodiversity enhancement and management. When complete it will be attractive to schools, wildlife and gardening groups.


The parks potential to act as a climate “sink”, thus contributing to the Council’s commitment to address climate adaptation, as well as contributing to the green infrastructure and ecological corridors in the county will also be explored in the proposal.

Essentially, the overall ambition of the Council is to create a parkland that will create a regional destination for health and wellbeing, attracting fitness and outdoor enthusiasts of all abilities, nature lovers and educational providers. A key objective will be to create connectivity back into the city along the River Nore Linear Park onwards onto the Nore Valley walking trail.

It is intended that this project will progress through the planning process under Part 8 later this year and that a funding application under the Outdoor Recreational Infrastructure Scheme (ORIS) will be submitted at the end of November to the Department of Rural and Community Development.

### Animal Welfare Charter Committee

The newly established Animal Welfare Charter Committee will have its first meeting in September. This new committee comprises of Elected Members, representatives from a number of animal welfare organisations and Council officials. The role of the Committee will be to monitor and provide oversight in the operation of the Council’s Animal Welfare Charter for Dogs and Horses.



### RMCEI (Recommended Minimum Criteria Environmental Inspection) Plan 2020

The EPA recently published their evaluation report on the 2020 RMCEI Plans submitted by each Local Authority. We are delighted that Kilkenny Co. Council received a score of High for 2020, retaining the score achieved in 2019.

#### RMCEI Enforcement Plan Evaluation 2020 Kilkenny County Council

This 2020 RMCEI Enforcement Plan evaluation assesses the key areas of: National Environmental Enforcement Priorities, Environmental Outcomes and Enforcement Resourcing & Plan Review. A summary evaluation is provided below with details of evaluation criteria overleaf. This evaluation is used in the Local Authority Environmental Performance Indicators, which is being reviewed in 2020.



### Household Waste Survey Postcard

The Environment Section came up with a novel way of ensuring that we make households aware of their obligation to separate food waste and partake in a 3-bin service - by issuing relevant households with a postcard.

The postcard will be sent to households within Agglomerations of over 500 people. Households receiving the postcard will be asked to log on to the Council's website and complete the survey.



A record of households receiving the postcard is being kept and a follow up notification will be issued if necessary to ensure that all households complete the survey.

## Supporting the ONE MILLION STARS PROJECT

The Environment Section continues to support the Amber Women's Refuge project by promoting the upcycling of materials to weave stars for the One Million Stars to End Violence Project. Working with the Arts Office, the section is promoting the upcycling of different materials to produce stars that would otherwise be put in the recycling bin. The project has just launched a transition year programme which is being advertised locally and nationally through the Local Authority Prevention Network (LAPN).



## The Community Environment Action Fund Scheme 2019/2020

Due to Covid restrictions, many projects that received funding last November were unable to meet the project deadline of August 2020. The Department of Communications, Climate Action & Environment has extended the deadline into the Autumn to allow projects to be completed. The Environment Section is currently contacting grant recipients notifying them of this project extension. As last year's scheme has been extended, the Department has indicated that there is a likelihood that the 2020 scheme for CEAF will not take place this year.

## Roadside Litter Campaign

Roadside litter remains an issue locally and regionally. Kilkenny County Council teamed up with the neighbouring counties of Carlow, Wexford and Waterford to produce a roadside litter campaign which calls out litter louts. Materials have been produced for social media and a radio collaboration with Carlow County Council ran on KCLR96FM in July. The campaign focuses on peer pressure to call out litter louts. As well as the social media campaign, communities are getting involved by promoting the campaign locally and secondary schools are now being offered the campaign materials to encourage them to run their own school litter campaigns.



## Waste Prevention Grant 2020

Eight communities received notification in August that they were successful in their application under the Waste Prevention Grant scheme. The grant promotes reuse and waste prevention at a local level. All projects can be completed within current covid restrictions and will be highlighted throughout October Reuse Month and in November during the Southern Regions Waste Roadshow.

**ENERGY OFFICE**

**Kilkenny County Council - ISO 50001**

The Energy Team in Kilkenny County Council is currently working towards ISO 50001 certification. ISO 50001 is the International Standard that enables organisations to establish the systems and processes necessary to improve energy performance, including energy efficiency, energy use, and consumption. The implementation of this standard is intended to lead to reductions in greenhouse gas emissions, energy cost, and other related environmental impacts, through systematic management of energy.

During the recent restrictions, the Energy Team has continued with the training, completing 10 days training and mentoring support via webinars and conference calls in conjunction with SEAI. The team is currently working on the final stages of the Performance Evaluation and auditing sections with the aim of gaining certification before the end of the year.

### National Energy & Climate Plan 2021 - 2030

The National Energy & Climate Plan 2021 - 2030 was launched recently. Under the Programme for Government, Our Shared Future, Ireland is committed to achieving a 7% annual average reduction in greenhouse gas emissions between 2021 and 2030. The Government recognises that Local Authorities play a key role in meeting Ireland's energy targets, particularly for climate change and energy efficiency.



### National Energy & Climate Plan

Some of the targets and objectives outlined for the local authorities and the public sector:


- Target of 30% reduction in CO<sub>2</sub>eq emissions by 2030 and a 50% improvement in public sector energy efficiency
- Public sector buildings to have a **B** Building Energy Rating (BER) by 2030.

Phase 2 of the social housing retrofit programme to bring dwellings more than 40 years old (30% of the social housing stock) to a B2 equivalent BER

### Kilkenny County Council - Energy Management

The Energy Office and 3CEA are currently working on completing the following energy management actions for 2020:

SEAI Monitoring & Reporting of the Council's energy usage for 2019. The initial indications suggest that the Council will exceed the 2020 target (i.e. to achieve 33% energy reduction) and are currently at 34% improvement in energy efficiency.

### FORWARD PLANNING

#### City & County Development Plan

The Planning Section continue to prepare the text for the Draft Plan, which is nearing completion. The forward planning team will brief all the Municipal District Meetings before the September Council meeting and dates for two workshops will be agreed with the Council. Following the workshops, which should take place in early October, the members will consider the draft plan for approval at the October Council meeting. It will be placed on public display for the next round of public consultation. Updates on the process are provided on the dedicated portal for the draft plan at [Ourplan.Kilkenny.ie](http://Ourplan.Kilkenny.ie).

#### Masterplans

In a parallel process a number of masterplans for the areas of Loughmacask, St Canice's Campus (the former St. Canice's Hospital) and the Fairgreen area of the City are under preparation. These

were also impacted by Covid 19. Work is continuing with the first of these Loughmacask being the furthest advanced. Issues arising from the public consultations held in February and those arising for internal and statutory consultations are currently being worked through by the Planning team. Members will be briefed before any draft masterplans are placed on public display.

#### Graiguenamanagh Local Area Plan

A draft joint Local Area Plan for Graiguenamanagh and Tinnahinch has been prepared and members of the Thomastown Municipal District were briefed at their meeting on June 10<sup>th</sup>. Carlow County Council have now also reviewed the plan and it is proposed to put the draft out on display in early to mid October for its statutory consultation of a minimum of 6 weeks.

#### Conservation Grants

Built Heritage Investment Scheme: Progress continues on projects approved under this scheme. Example of works include rethatching, slate repairs, external render and shopfront repairs. A total of €98,000 has been secured for projects across the County.

Historic Structures Fund: The Bridewell, Thomastown and Windgap Creamery are the two projects approved funding by the Department and are currently in progress. The total funding for these two projects combined is €40,000.

In the July Jobs Stimulus Package, 2 further projects have been submitted to the Department for consideration of funding as follows:

- Bridewell, Thoamstown for an extra €25,000 is applied for.
- Mid Terrace house, Mullinavat - €35,230 is applied for.

Historic Towns Initiative (HTI) Phase II: Kilkenny County Council has successfully secured funding

of €80,000 from the Heritage Council under the HTI Phase II for St. Mary's Church.

The funding will support repair works to the railings of the Church on Green Street; to the piers of the footbridge over the Kings River in Callan; and select areas of archaeological excavation. Works must be completed by the end November this year.

Community Monument Fund 2020: The National Monuments Service have launched a further grant scheme and Kilkenny County Council intend submitting applications under each stream as follows:

**Stream 1** - An application will be submitted for remedial works on the City Wall located on the Abbey Quarter site;

**Stream 2** - An application will be submitted for the compilation of a Conservation Management Plan for Kenny's Well.

#### ***Building Control***

A total of 222 commencement notices were received in 2020 up to the end of August. This compares with 204 commencement notices for the same period in 2019.

Disability Access Certs and Fire Safety Certs online are now available on the BCMS.

#### ***Taking in Charge***

Works continue to be carried out on the following estates:

- Rath Ullard
- Banagher Court, Piltown
- The Green, Ballyfoyle
- Glenvale, Ballyragget
- Newpark Crescent

#### **Vacant Sites**

Seventeen sites were added to the Register for 2020. The valuations are now complete, and the next step is to notify the owners, who will then

have an opportunity of appeal to the Valuations Tribunal.

There are currently 34 sites on the Vacant Sites Register. A total of 19 of these are now liable for the 7% levy. The Council were in the process of issuing payment demands in March, however that process was halted following the Government's Emergency Order. The process will recommence to ensure compliance with statutory deadlines. Two sites have had their levy discharged to date.

The legislation is having an impact as the number of cancelled entries due to site activation or improvement now stands at 12 sites.

## **PARKS**

### **Playgrounds**

Playgrounds across the county were very busy during the summer months following the lifting of Government restrictions. Callan Playground works are now completed utilising funding under the Rural Regeneration Development Fund (RRDF). Work at Blackthorn Hills in Ferrybank, which needs major repairs to the safety surfacing, is also underway.

### **South East Greenway**

Works have commenced on the rail lifting contract on the South East Greenway which runs from Ferrybank in South Kilkenny to New Ross, terminating at Mount Elliot. The rails and sleepers are being lifted for collection at Rosbercon at the old railway station and from there will be returned to CIE to their central yard

Two Part 8 planning applications for Greenway Car Parks to facilitate access to the Greenway at Raheen, New Ross, Ballyverneen, Glenmore and Ferrybank have been lodged and submissions are invited from the public. These applications are available for inspection in the Ferrybank Area Office, County Hall Planning Office and in New Ross Municipal District Offices based at the Tholsel in New Ross.

### Woodstock Gardens

Woodstock Gardens in Inistioge had an exceptionally busy summer due to many more staycations than in normal years. Initially it offered local people a place to exercise outdoors. However, since early summer, with the easing of restrictions, the gardens were extremely popular with families bringing children to use the playground and to run free through the woods and gardens.

The newly developed trails from Inistioge to the gardens have also proved very popular. Plans are being finalised to seek further funding to extend the trails to the Red House Quay area and Waterfall. An application will be made under the Outdoor Recreation Infrastructure Scheme (ORIS) later this year.

Typically, the tea rooms housed in the conservatory would have opened at Easter but due to the restrictions we have instead offered the

service of a mobile coffee truck for refreshments outdoors. We used the temporary closure of the conservatory to facilitate the upgrade of the building, including painting, tiling and cleaning. Thomastown Artist Gill Campden is currently working on a mural for the interior wall of the building.

during Storm Ophelia. This area when completed will provide for a relaxing seating area set in the heart of the gardens.

### Ferrybank Neighbourhood Park

Work is now practically complete on the construction of the Ferrybank Neighbourhood Park. Some delays due to Covid and wet weather were encountered along the way but we are certain the Ferrybank community will be delighted with the result. The final snagging is underway along with the independent playground inspection to satisfy the public liability insurers. There will be something for all in this park with both active and passive areas for play and exercise. The park is part of a wider network of green spaces in the Ferrybank area with plans in the future to create linkages to the Greenway when it is developed.

The park is being jointly funded by the Department of Housing, Planning, and Local Government (50%) under the Local Housing Infrastructure Activation Fund (LIHAF) and by Kilkenny County Council (25%) and Waterford City and County Council (25%).

### Amenity Grants

The majority of grants have now been paid out for 2020 with all expected to be drawn down by the end of October.

### Outdoor Recreation Infrastructure Scheme (ORIS)

Funds from the ORIS enabled the further upgrade of the loop walk at Brownswood, Freshford. This is a continuation of works carried out last year and will allow easier access to a popular outdoor trail for all. Works will commence immediately on a similar but more uphill trail at Tory Hill, Mullinavat. Erosion of the informal trails on Tory Hill has been caused by volumes of people using the trails but also by blocked drainage. The proposed works will remedy this situation across the most popular places on the hillside trail. All works are being carried out with Coillte's permission as the trails are located on their lands. Funding from the same scheme has been granted for a communications plan for Woodstock Gardens. This has enabled the employment of social media experts to help boost the profile of the gardens and keep the public informed of news and events. It will also be used to print and design promotional material including a reprint of our very popular book on the history of the gardens which contains some amazing historical pictures of Woodstock in its heyday during the Victorian period circa 1840 to 1890.

Funding was also secured to undertake enhancement works to the existing boardwalk in Silaire Wood along the River Barrow in Graiguenamanagh. Following a competitive

tendering process the contract was awarded and works have commenced. The use of recycled material for this project demonstrates the Council's commitment to sustainability and the reuse/repurposing of materials and still provide an attractive, maintenance free, rot proof and vandal resistant piece of leisure infrastructure for many years. The works will also include improvements to the loop walk within the woods and the project is expected to be completed by the end of November.

## Hillcrest/Banagher Court Piltown

Works took place in July/August to upgrade the green and connect two residential areas at Banagher Court and Hillcrest, Piltown. Serious anti-social behaviour incidents in the past were taking place in this area and dumping and littering was also a problem. As part of the planning decision for the Banagher Court estate, a pedestrian link was to be maintained between the two areas of open space in each estate. A new path has now been provided.

## Pollinator Planting Thomastown

The Parks Department assisted the Thomastown Area Office in a landscaping project along the Quay in Thomastown. Two large new perennial plant beds were planted with pollinator friendly planting which will provide an abundance of colour and bloom in front of the recently completed Quayside Carpark. The Thomastown Tidy Towns committee will be assisting in the maintenance of the beds going forward.

The tourism team helped researched and co-write the content to record and produce an audio guide - 'Medieval Kilkenny Tour'. This guide tells the story of all the attractions along Ireland's Medieval Mile. The audio guide can be accessed at [kilkenny.ie](http://kilkenny.ie). It is also available on all major podcast platforms, so it is easily and instantly accessible.

### Kilkenny Welcome Team

Kilkenny Welcome Team is a positive initiative aimed at supporting Kilkenny's Tourist Sector. It was established by Kilkenny County Council and developed in association with Kilkenny Tourism and the newly established Kilkenny Recovery Task Force and was launched by Brian Cody in early July. 20 volunteers have signed up and have completed training. They welcome people to Kilkenny and help with their information needs. We are very grateful and proud of our volunteers who are providing an invaluable service to visitors and locals alike. Our tourism partners have really embraced this initiative and provided huge support to the volunteers.

### More to Explore

## CLAR

10 applications have been submitted for consideration under CLAR for funding of €306,650 in Kilmanagh, Clogharinka, Muckalee South, Collaghmore, Kilmacar, Mothell, Kilmaganny, Muckalee North, Crosspatrick and Kilmanagh.

## FIRE SERVICES

### Capital Projects

Kilkenny Fire Service have taken the delivery of 2 second hand fire engines for Urlingford Fire Brigade to replace their 18-year-old vehicles. Revised layout drawings and cost plans for the new Urlingford Fire Station have been sent to the Department for approval. The delivery of a new fire engine for Callan has been delayed due to Covid-19 restrictions and is now due at the end of September 2020.

### Fire Safety Certificates

80 applications for fire safety certificates were received to 31<sup>st</sup> August 2020. This is a 20 % increase in 2019 applications for the same period last year. These applications were administered by staff working from home and from our Headquarter station due to Covid-19.

### Fire Services Acts 1981 & 2003

- Fire Prevention staff made targeted inspections of premises both to provide advice and to enforce legislation.
- 1 Fire Safety Notice under the Fire Services Acts 1981 and 2003 was revoked during this period.

### Community Fire Safety

Ongoing public messaging campaigns are being maintained through our social media channels to encourage members of the public to install smoke alarms and to test their smoke alarms once a week to ensure that they are working.

Talks and information to various communities is on hold due to current Public Health restrictions.

Personnel have been carrying out Home Fire Safety visits to vulnerable people

Kilkenny Fire and Rescue Service Primary Schools Programme (PSP) is postponed for the moment. This programme has been running since 2006 and over 19,112 3<sup>rd</sup> class pupils have received fire safety awareness talks.

### Operations

Fire Brigades responded to 506 turnouts up to the 14<sup>th</sup> August 2020 compared to 444 in 2019.

Increase of 40 % in fire calls and a decrease of 49% in road traffic accidents.

## LEO/ECONOMIC DEVELOPMENT

### Autumn Training Programme 2020 Available to Book Online Now

The Local Enterprise Office has launched the Autumn 2020 training programme schedule for entrepreneurs, owner/managers and employees of micro-enterprises. Due to Covid19, all training courses will be delivered online. There is a total of 36 courses on the programme including Start Your Own Business Courses and Webinars.

As Brexit looms, the onus is on business owners to be aware of how it could significantly impact on their current economic activity. To help prepare and inform businesses, the Local Enterprise Office will host a number of events including "Brexit Business Advisory Clinic" on Thursday 8<sup>th</sup> October which involves one-to-one telephone meetings with our Brexit Advisors. In addition to this, there will be 2 Prepare your Business for Customs workshops. All of these events are free but pre-registration is required.

In 2020 to date, over 1,262 participants have attended training programmes organised by the Local Enterprise Office ranging from Start your Own Business Courses, Social Media Marketing Courses to Covid19 related Courses and Webinars. The Autumn Training schedule is designed to support small businesses and start-ups in our local communities.

**Microfinance Ire. Opens new €15M Covid19 Fund**  
Microfinance Ireland has opened its new €15 million Covid-19 fund to support small businesses through the current period of uncertainty and to protect jobs that have been impacted by the coronavirus pandemic. Small businesses can apply for loans up to €25,000 for a three-year term with no repayments and no interest due for the first six months of the loan. The Local Enterprise Office is supporting clients by assisting with loan application. All MFI loans

submitted via the Local Enterprise Office can avail of a reduced interest rate of 4.5%.

### LEO STATISTICS FOR 2020

- **€319,190** approved in **financial assistance** to 16 businesses linked to the creation of 111 jobs over a 3-year period - (€272,415 in *Business Expansion Grants* and €46,775 in *Feasibility Study Grants*)
- **1,262** business owners and employees attended 69 core **training programmes** including seminars from Financial Training to Management Development Programmes
- **747** students from 14 schools participated in the **Student Enterprise Programme** which fosters a spirit of entrepreneurship from an early age
- **793** entrepreneurs have received **one-to-one mentoring** to assist them in relation to particular issues within their business ranging from business continuity to ICT
- **384** entrepreneurs attended **Business Advisory Sessions** with LEO staff to discuss starting or growing an existing business (*including remotely from March 2020*)
- **311 Covid-19 Business Continuity Voucher** applications were approved totalling €676,719
- **197 Trading Online Vouchers** were approved totalling €456,951.24 in order to assist businesses to implement e-commerce within their business
- **102** participants attended **6 Start Your Own Business programmes** which explores all the aspects encountered when starting up a new business (*including remotely from March 2020*)
- **12 Microfinance loan applications** have been submitted to Microfinance Ireland (1 pre COVID and 11 COVID related) of which **11** have been approved to date with total loan value of **€296,000**
- **6** businesses have participated on **Lean for Micro** in order to assist them to look at their competitiveness and innovation specifically in relation to Brexit
- **5** businesses have been approved **Technical Assistance Micro Export Assistance Grants** in order to assist them access overseas markets totalling €10,496



### Partnership with Music Generation Kilkenny


As part of our Community wellbeing initiative, we recently partnered with Music Generation Kilkenny to promote wellbeing amongst families with young children. Led by experienced practitioner, Karen McMahon, short workshops were shared online twice a week for the month of August. These were very well received.

### Freegal Music Streaming Service Launched

Freegal is a free music streaming service which has been added to our suite of online services. Access is available with your library card from Kilkenny County Council Library Service. Users have three hours unlimited streaming per day and up to three free downloads per week. Freegal offers access to 15 million songs, including Sony Music's catalogue of legendary artists, and over 40,000 music videos.

### Summer Stars

Our national Summer Reading campaign ran throughout July and August this year. With children spending more time at home, we have tailored this year's challenge by increasing access to more eBooks and eAudiobooks than ever before, along with eMagazines, and a programme of storytimes/quizzes. **FINANCE**

The expenditure by service division to the end of August is set out in table 1. Total Expenditure for the eight months to the end of August was €60.5m compared with the annual budget of €83.6m.

The bank overdraft facility was utilized six times during the eight month period to the end of June 2020. The earlier payment by Government Departments of grant monies including the Local Property Tax allocation has assisted cashflow since the beginning of the Covid-19 crisis.

The audit of Annual Financial Statements for 2019 commenced on 13<sup>th</sup> July. The audited statements will be presented to Council later in the year on completion of the annual audit by the Local Government Auditor.

#### **Commercial Rates Appeals Update**

The Valuation Office conducted a revaluation of all commercial properties throughout County Kilkenny to come into effect for the year 2018 as part of its ongoing programme to revalue all such properties within the State.

The following is an update on appeal outcomes and outstanding appeals:

- 195 Rate Customers appealed their valuation to the Valuation Tribunal.
- Total value of rate demand under appeal is €4.5m (22.6%).
- 154 appeals have been completed to date (22 withdrawn).
- 126 of the 154 appeals have resulted in a reduction in rates income, 5 confirmed the decision of the revaluation, 1 resulted in an increase in rates income & 22 were withdrawn.
- Income lost to date = **€715k.**
- 40 appeals outstanding (1 appeal withdrawn)

If this trend continues the total loss in annual income will be in excess of €1m.

**Impact of covid-19 on Council Finances.**

As previously advised to Council, Covid-19 is presenting serious financial challenges as all income streams have been impacted. The estimated shortfall in commercial rates income for 2020 is €8.7m. The Government have announced a six month waiver on commercial rates for businesses impacted by the crisis and that compensation will be provided to Council. The estimated income from the compensation is €5m leaving a net shortfall of €3.7m. Income from goods and services is also expected to be down by €1.7m. Additional Covid related costs of €0.5m are also forecast for the year.

This leaves an estimated shortfall for 2020 of €5.9m in the absence of any further Government support.

Expenditure in a number of areas in the 2020 budget totalling €2.35m has been deferred until further clarity is obtained regarding the income loss for the year.

There is a significant risk that the Council will incur a deficit for 2020 based on the current projections.

**Budget 2021**

The budget process for 2021 has already commenced. As already stated the covid-19 crisis is presenting unprecedented financial challenges for the Council in the current year and will continue to do so into 2021. All income streams are and will be impacted for the foreseeable future. Council will be asked at the September meeting to maintain the same local adjustment factor for local property tax for 2021. This will maintain income of €1.1m which will be essential in maintaining essential council services for 2021. A separate report is being sent to Elected Members on this matter.

**Re-Start/Restart Plus Grants**

The Re-Start Grant Plus builds on the original Restart Grant and is a support for small and medium enterprises to assist with the costs associated with re-opening and re-employing workers. Subject to qualifying criteria any businesses that occupies a commercially rateable premises or where rates are paid on behalf of a business owner and attributable to the business premises occupied can apply. In order for a business to qualify they must also meet the following criteria:

- Be a commercial, trading, entity
- Operate from a premises that is commercially rateable by a local authority
- Have 0 - 250 employees
- Have a turnover of less than €100k per employee to a maximum of €25m
- Have suffered a 25%+ loss in turnover between 1 April and 30 June 2020
- Commit to remain open or to reopen if closed
- Intend to retain employees that are on the Temporary Wage Subsidy Scheme (TWSS).

In most cases the grant will be the amount of the rates assessment for the premises for 2019 with a minimum grant of €4,000 and a maximum grant of €25,000 (or maximum of €15,000 for businesses that received the maximum €10,000 under the original Restart Grant Scheme). An additional 40% for pubs, bars and nightclubs that remain closed in accordance with Government Guidelines announced by An Tánaiste, Leo Varadkar on the 28<sup>th</sup> August.

To date, Kilkenny County Council has received 1,079 Restart Grant Plus applications. The Restart Team has approved and paid 720 applications totalling €3,852,500. This is in addition to 966 applications processed under Restart 1 with a total payment of €2,948,925.

In addition to processing applications the Re-Start Team has dealt with over 1,300 Re-Start phone calls and 2,400 e-mails since the commencement of the project. The Restart Plus Grant continues to be actively publicised in local and social media platforms.
