In her presentation she gave an overview on the following:

- Mix of Units to suit all approved applicants.
- Proposed 3D view of completed development on each site.

- Submissions and observations received during Part 8. Two Third Party External submissions received.
 - Issues raised: Water Pressures/Supply in Area

- Road Safety
- Overlooking/Privacy
- Positive feedback in relation to tackling dereliction and vacancies.

She advised the Members that the Chief Executive is recommending to the Council that the proposed development proceed in accordance with plans available at public consultation and the revision/recommendations of the Planning Department.

Contributions were received from Cllrs. Mary Hilda Cavanagh, Pat Fitzpatrick, John Brennan, Michael McCarthy, Denis Hynes and Joe Malone. Members welcomed the proposed development of 20 houses in Johnstown and the regeneration of derelict and vacant properties. They complemented the Housing Staff and the Design Team on the quality of the units being provided across the County. Members raised their concerns in relation to road safety at the junction of the Rathdowney Road.

It was proposed by Cllr. Mary Hilda Cavanagh, seconded by Cllr. Pat Fitzpatrick and agreed that:

(c) (i) *Deontas Feasachta Frith-Bhruscair/Frith-Graifíti* 2021 Anti-Litter/Anti-Graffiti Awareness Grant 2021

Mr. Sean McKeown presented his report on Anti-Litter/Anti-Graffiti Awareness Grant 2011. The Council received a grant of \notin 20,000 from the Department of Environment, Climate & Communication. Kilkenny County Council is required to provide a further \notin 10,000 as match funding. Total budget available is \notin 30,000.

A number of activities included in the Litter Management Plan can be undertaken from this funding and these are listed in the Report.

A balance of €11,075 is available for Community Projects. This funding was advertised in March 2021. 20 Community Applications were received. All applications were evaluated by Environment and met the grant criteria. It is recommended to the Elected Members that the 20 applicants each receive a grant as listed in the Report – Total value €11,000.

It was proposed by Cllr. Andrew McGuinness, seconded by Cllr. David Fitzgerald and agreed that:

"That Kilkenny County Council approves the payment of Anti-Litter/Anti-Graffiti Awareness Grants in accordance with the list circulated to the Members."

(d) (i) Deontais Imeachtaí Pobail - Community Event Grants

Ms. Mary Mulholland presented her report on the Events Grants Scheme for 2021. The Budget allocated for the 2021 Scheme was €22,400. Six applications were received for the small events. The Council are in a position to fully fund these applications.

It is recommended that the Elected Members approve the six grants in the total sum of $\in 8,100$.

It is proposed by Cllr. Eugene McGuinness, seconded by Cllr. Pat Fitzpatrick and agreed:

"That the Event Grants 2021 totalling \in *8,100 are hereby approved by the Members of Kilkenny County Council, as per report circulated."*

(ii) Maoiniú Deontas Geata Uisce - Watergate Grant Funding

Mr. Martin Prendiville advised Members that the Watergate Theatre has secured a grant of \notin 255,000 under the Cultural Capital Grants Scheme for energy efficiency improvement works to the Theatre and to reduce their carbon footprint.

The following works will be undertaken:

- Insulation walls/roof etc.
- Replacement of doors/windows.
- Upgrade Lighting.

Kilkenny County Council is required to provide match funding for the grant to the value of \notin 255,000 (50%). He advised that this work is not included in the Three Year Capital Budget as the grant had not been secured at the time that the Members were considering the Capital Budget. It is recommended that the work be undertaken in upgrading the Theatre to reduce their carbon footprint.

It was proposed by Cllr. Andrew McGuinness, seconded by Cllr. John Coonan and agreed:

"That Kilkenny County Council provides matching funds of $\in 255,000$ for the energy improvements works in the Watergate Theatre."

(e) (i) *Cur i láthair: Kilkenny.ie, Shop Local, Taste Kilkenny* Presentation: Kilkenny.ie, Shop Local, Taste Kilkenny

Ms. Fiona Deegan, LEO gave a PowerPoint presentation to the Elected Members on Kilkenny.ie, Shop Local, Taste Kilkenny, Invest Kilkenny, Careers etc.

In her presentation she gave an overview on the Kilkenny Branding and website owned by the Council. The Communication Team in the Council manages the content on all social media platforms. She presented various content from Kilkenny.ie to showcase what is happening in Kilkenny and the content being provided from a number of areas such as Kilkenny Tourism, LEO etc.

The various platforms managed by Kilkenny County Council include – Facebook, Twitter etc.

Recent footage of campaigns undertaken were shown to the Members in particular the promotion of Taste Kilkenny with the "2 Jackie's" – Jackie Tyrrell and Jackie Hurley. Upcoming campaigns will be "Discover Kilkenny" and "Invest Kilkenny". "Shop Local" campaign was run in conjunction with KCLR across the County.

The Kilkenny brand enables companies to list jobs under the careers area and this is being used by private companies.

The whole purpose of the Kilkenny Brand is to promote the County and sell Kilkenny to wider audiences under the one Brand.

She presented an overview on the followers on the various platforms.

Contributions were received from Cllrs. Fidelis Doherty and Andrew McGuinness. Members thanked Ms. Deegan for the overview and encouraged all to highlight all that is good about Kilkenny and to encourage people to visit and shop local also.

(f) (i) *Tuarascáil Mhíosúil an Phríomhfheidhmeannaigh* Chief Executive's Monthly Report

Ms. Colette Byrne, Chief Executive presented her Monthly Report.

Ms. Byrne stated that she wished to clarify the roles of the Council and the Abbey Quarter Partnership who are both delivering project in the Abbey Quarter. She outlined that there are two Entities operating within the development of the Abbey Quarter site and each have separate functions. Members approved that Kilkenny County Council should enter into a partnership for the development of the buildings on the site. The Abbey Quarter Partnership was set up between Kilkenny County Council (50%) and NTMA (50%). The Partnership is responsible for progressing plans for delivery of the buildings. It borrows money, lets the building on a commercial basis and repays money borrowed.

The County Council is responsible for the Public Realm which is 60% of the entire site. Kilkenny County Council is responsible for the development of the Riverside Park, Skate Park, Brewhouse Square, Mayfair Library, upgrading of the Tea Houses and the park around St. Francis Abbey along with the Urban Street. The Council avails of any opportunity to seek grant funding such as URDF, Fáilte Ireland and in addition provides capital funding from our own Capital Budget for to match grant aid where needed.

The current development of the Brewhouse and the public realm is being delivered by one Contractor in the interest of efficiency, continuity and pracility but is funded by the two separate entities.

The provision of the Temporary Car Park which is a meanwhile use for up to seven years will be delivered by the Abbey Quarter Partnership. Kilkenny County Council will contribute to the cost of the Coach Park.

She re-iterated that there are no free buildings available, no free rent, buildings are let on a commercial basis by the Abbey Quarter Partnership.

Ms. Byrne advised that it is expected that the Contractor for the development of the Library will be onsite shortly and it is expected to be completed in 2023. Detailed designs on the new Urban Park and Street are at an advance stage. There is very positive feedback on the Riverside Park & Skate Park on the design and quality of work.

She advised that a full update will be given at the December Council meeting.

Cllrs. Peter Cleere and David Fitzgerald thanked the Chief Executive for the clarification.

Cllr. Peter Cleere raised a query in relation to the loss of rate income following the revaluation. He stated that the Council cannot sustain a loss of €1m in rates. The Council was guaranteed that the revaluation of properties would not result in a loss of income for the County. He proposed that a letter be sent to the Minister for Housing, Planning & Local Government seeking compensation for this loss. This was seconded by Cllr. Pat Fitzpatrick and agreed by all.

Contributions were also received from Cllrs. Pat Fitzgerald, Andrew McGuinness and Mary Hilda Cavanagh.

Cllr. Pat Dunphy requested the Council to carry out a publicity campaign on the Register of Electors on all social media platforms to encourage young people to register.

Cllr. David Fitzgerald spoke in relation to the lack of rental accommodation in Co. Kilkenny. He stated that there are vacant houses available but are not being made available due to the cost of improvements and building regulations etc. He requested that the Council prepare a report on the level of vacant property and proposals to put these houses back in use.

Cllr. Fidelis Doherty thanked all for their input on the Chief Executive Report.
