Cathaoirleach Andrew McGuinness opened the Special Meeting and welcomed all joining the meeting remotely.

Ms. Anne Maria Walsh, Meeting Administrator referred to the Members statutory obligations concerning Ethical Legislation Disclosure at meeting and Disclosures in advance of meeting. Details have been sent to all Elected Members in advance of this meeting. Members were advised that if there were any further declaration of interests that they should advise in advance of any discussion on that particular submission.

Mr. Denis Malone advised that an Errata page to the Chief Executive Report has been circulated in advance of this meeting.

The list of submissions under Section 3.1 omitted to reference this individual submission from the main list of submissions in Section 2 submissions received. The references are KKC162-25 and KK-C162-103.

Submissions KK-C162-60 – Michael Keogh's was incorrectly assigned to Rath Ullard instead of relating it to lands at Raheen, New Ross and Greenway facilities development. The Chief Executive recommends additional text to provide for uses related to Kilkenny Greenway.

Submission KK-C162-419 – National Transport Authority [NTA] was inadvertently omitted from the published report. This submission related to guiding principles from NTA, the support for cycling, modal shift public transport provision and importance of universal design. The Chief Executive recommends enhanced text for approval by Members.

Mr. Sean McKeown advised that 463 submissions were received. The submissions have been grouped into various categories to enable the Members to deal with a number of submissions together on the same theme. He listed the seven categories for Members information.

*Amend the Qualifying Criteria for Rural Housing on Page 96 of the Draft Plan as follows (yellow highlighted text is additional):*

*"2. Persons with a demonstrable social need to live a particular local rural area:*

*a. Persons born within the local rural area, or who have lived a substantial period of their lives in the local rural area (minimum 5 years), who have never owned a rural house and who wish to build their first home close to the original family home. Persons born in the area without having lived for the minimum of 5 years must be able to demonstrate strong family and social connections to the area to demonstrate a demonstrable social need."*

***Amendment 2:***

*Amend the proposed policy on Rural Nodes on Page 40 of the Draft Plan as follows (red text is additional):*

***Proposed policy under Section 4.7***

*"Below the level of the Smaller town/village in the settlement hierarchy is the wider rural area containing Rural Nodes which are small generally un-serviced settlements characterised by an existing clustering of houses around a limited level of support infrastructure such as a school, church or shop. These Rural Nodes are listed in table 4.4. The list is not exhaustive and settlements not listed displaying these characteristics may also be considered as nodes for the purpose of the plan. For multiple housing developments (2 or more houses in a cluster) 20% of the houses proposed can be made available for people who do not meet the requirements of the rural housing policy. For one off houses or schemes where 20% cannot be reached in whole housing units in and around these nodes applicants will be required to satisfy the Council rural housing policy. Development will be limited to incremental local growth appropriate to their size and character."*

*and to amend the Draft Development Plan accordingly.*

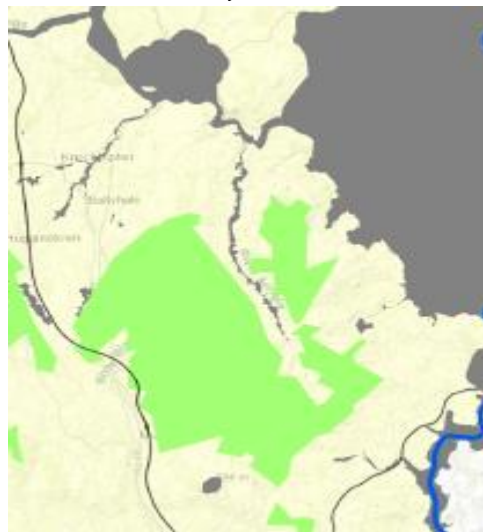
It is noted from the Members that they have issues in relation to the designation of this area as “Acceptable in Principle” in the Draft Plan.

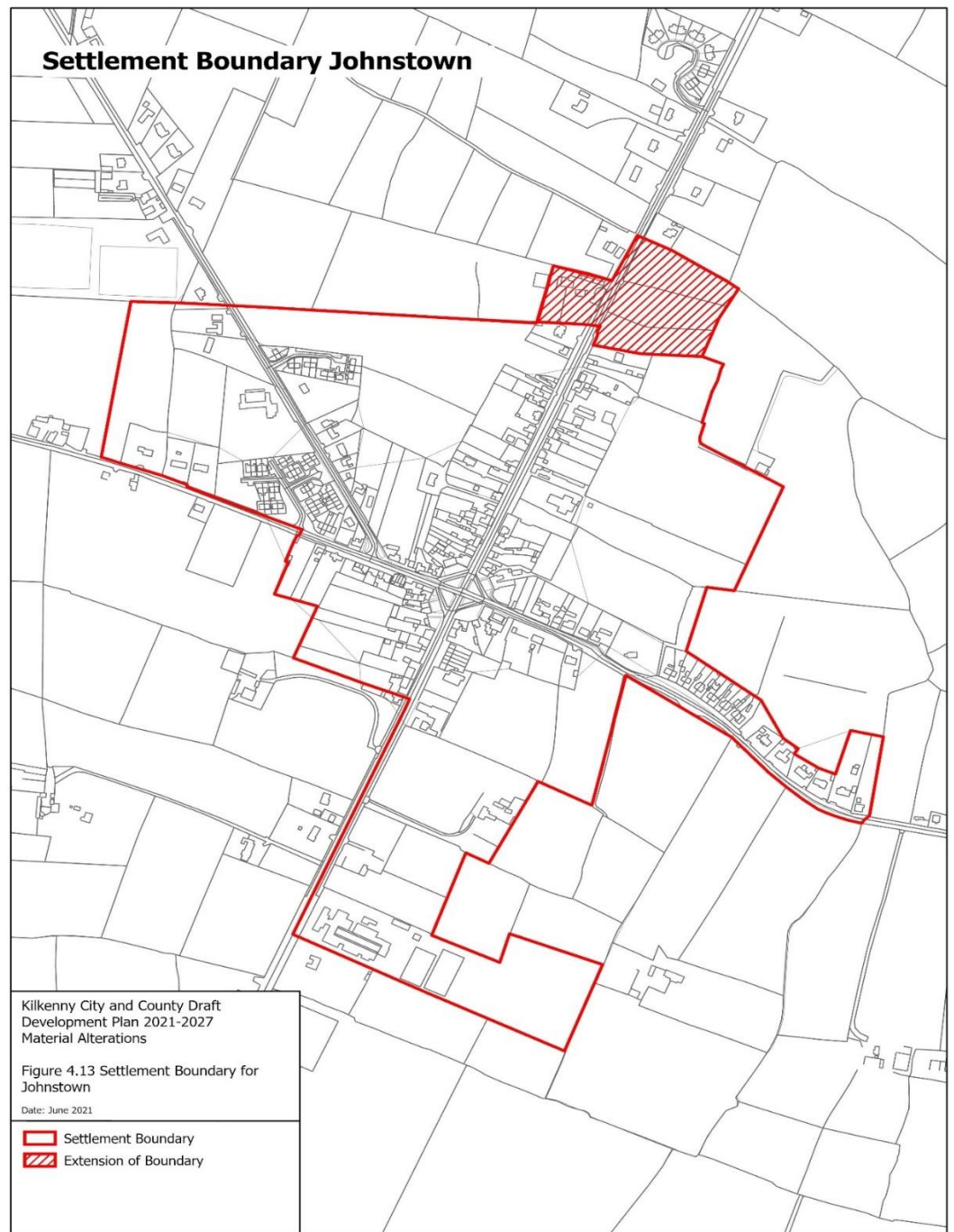
**(i) Submission No. KK-C162-161 Fenians GAA Club.**

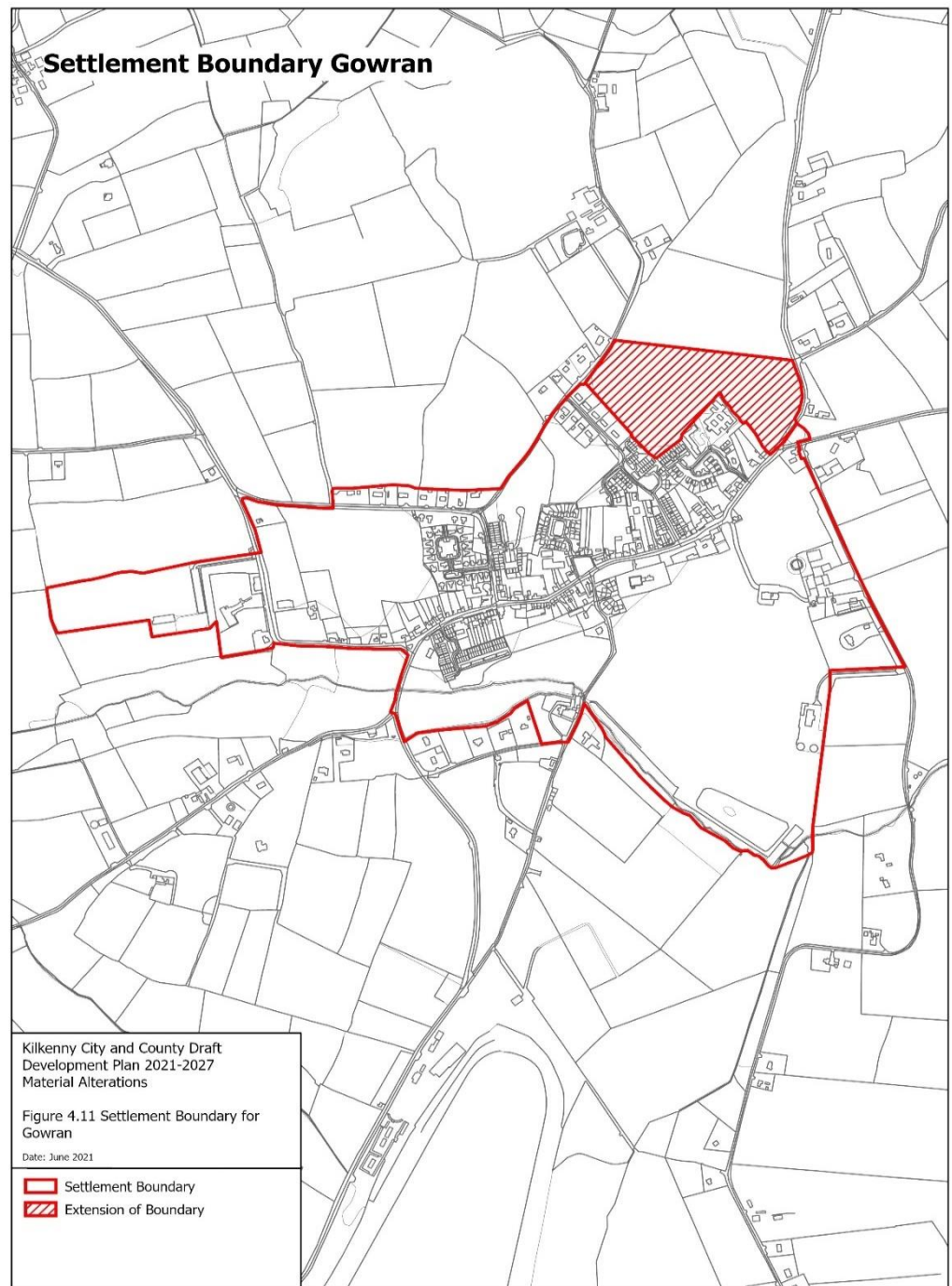

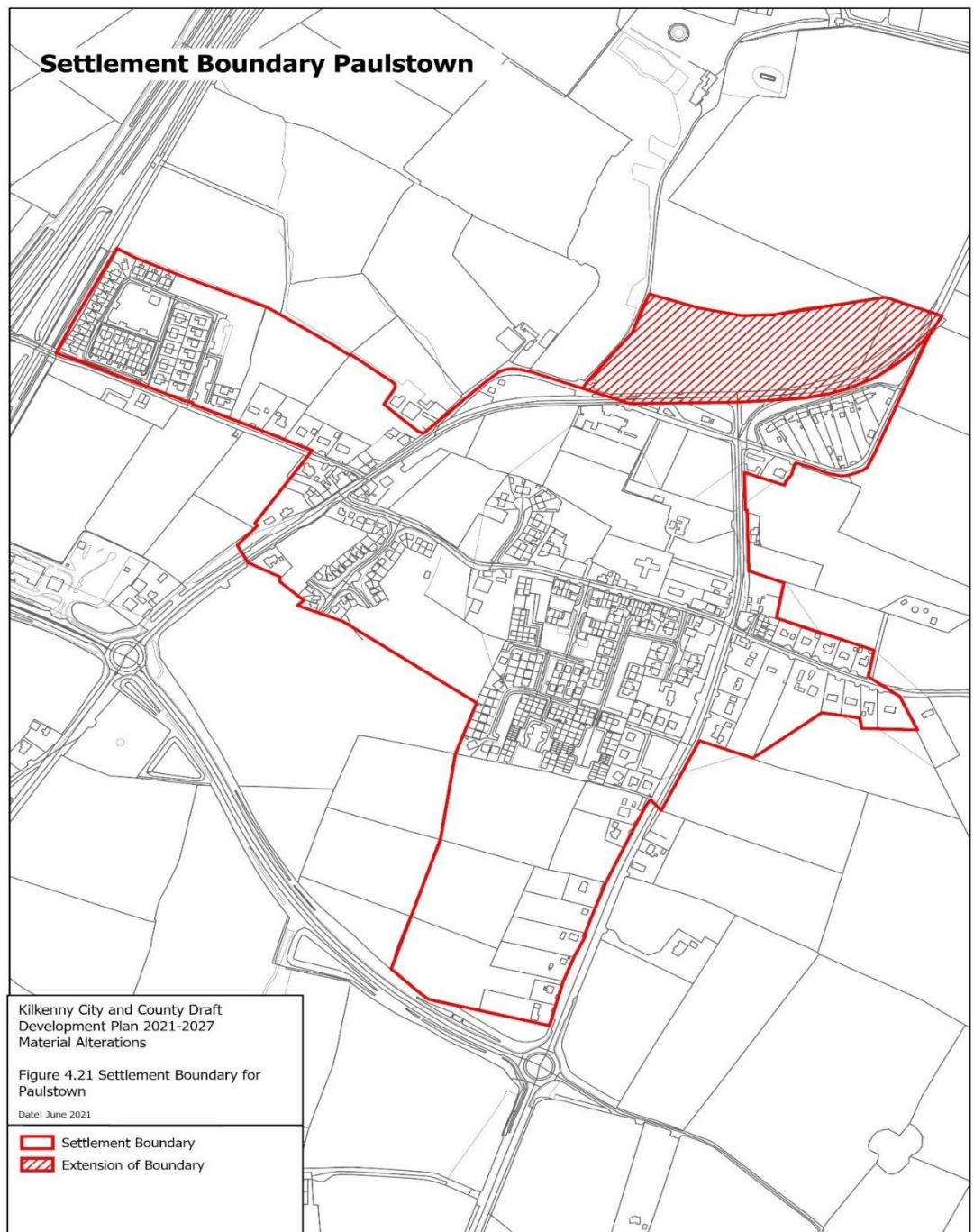

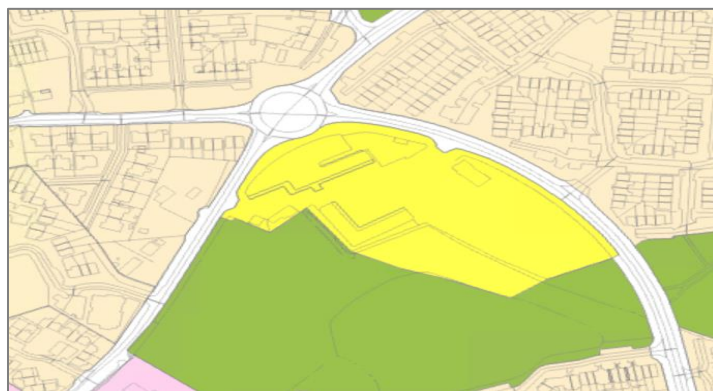
- *That existing grid infrastructure should be used where possible in preference to erecting new grid infrastructure.*

*"That the Elected Members of Kilkenny County Council do not accept the recommendation to zone the lands to Neighbourhood Zoning and that the existing zoning of Amenity/Greenlinks/Biodiversity remains unchanged."*

All Members present were in agreement.



- (ix) Cllrs. Andrew McGuinness and Mary Hilda Cavanagh requested clarification on wind energy development in Castletown. Mr. Denis Malone advised that no submissions have been received in relation to any lands at Castletown and wind energy development.

Mr. Denis Malone advised that the zoning of lands in Thomastown and Callan will be dealt with during the review of the Local Area Plans. As part of the preparation of any Town Plan the allocation of extra population to an area will be considered. The Draft Local Area Plans will be reviewed as quickly as possible after the adoption of the City & County Development Plan.

Mr. Malone advised the Members on the next steps. He advised that the Chief Executive's Report on the 463 submissions on the Draft Plan have now been considered. The number of submissions received is a good reflection on the public engagement despite being done virtually. The changes/amendments made today will be drafted into a document which will go on public display within the next three weeks. The agreed amendments will all need to be environmentally assessed. No further amendments to the draft plan can be considered after this meeting.

The public display period for consideration of the material alterations will be four weeks. It is expected that the Draft Plan will come back to the Members for final adoption in late August/early September. The deadline for adoption of the Draft Development Plan is 8<sup>th</sup> September, 2021.

It was proposed by Cllr. Andrew McGuinness, seconded by Cllr. Mary Hilda Cavanagh and resolved that we:

*"We, the Members of Kilkenny County Council, having considered the Chief Executive's Report on the submissions received to the Draft City & County Development Plan 2021-2027 under Section 12 (5)(a) of the Planning & Development Act 2000 as amended, at the meeting of Kilkenny County Council held on the 8<sup>th</sup> June, 2021, do hereby resolve that the Draft City and County Development Plan be amended as set out in the Chief Executive's Report dated 25<sup>th</sup> May, 2021 (and Errata dated 7<sup>th</sup> June 2021), subject to the directions as recorded in the Minutes above.*

All Members present were in agreement.

Cllrs. Andrew McGuinness, Mary Hilda Cavanagh and Tomás Breathnach thanked all the Executive and in particular all the Planning Staff for the enormous amount of work that has gone into the Draft Development Plan. They acknowledged the time given to the Elected Members on all the issues raised. Their patience and understanding shown to the Members on the difficult issues presented.

The Members also thanked the public for their engagement in the Development Plan process. The number of submissions received is a reflection of the public interest in the development of their areas and County.

They also thanked their fellow Councillors for their work in considering the Draft Plan and the Chief Executive's Report for the many hours of discussions/meetings held in ensuring that all issues in the Chief Executive's Report were considered and seeking the best solutions to the changes/amendments agreed at today's meeting.
