Regional Actors & Policy

The RSES

Three priority areas:

- **Decarbonisation;**
 - Objective to develop a Regional Decarbonisation Plan to provide a framework for action on de-carbonisation across all sectors.
- **Resource Efficiency,**
 - Using the Earth's limited resources in a sustainable manner while minimising impacts on the environment.
- **Climate Resilience;**
 - Support measures to build resilience to climate change throughout the Region



- **Four Climate Action Regional Offices (CARO)**

- Established under Action 8 of the National Adaptation Framework

- **CARO deliver the Local Government sector's obligations**

- provides guidance, advice and support to L.As.
- Over six key areas
 - Adaptation,
 - Mitigation,
 - Citizen engagement,
 - Training/education,
 - Knowledge development,
 - Governance & partnership



Regional Policy & Actions

Kildare is the lead authority for the Eastern & Midlands CARO. (E&M CARO)

17 Local Authorities in the E&M CARO

Kilkenny is a Partner County

The CAROs coordinate climate action at regional and local levels

17,000 LA staff received training to date by CARO

The KCC Adaptation Strategy 2019 was part of the National Adaptation Framework (NAF) which resulted from the Climate Action and Low Carbon Development Act 2015.

KCC Examples of Progress to Date

Kilkenny County Council Climate Adaptation Strategy 2019-2024

- KCC leading on upgrade of 75,00+ public lights
- Facilities Projects

- A 33% improvement in the councils' energy efficiency already achieved.
