TC70 - The Paddocks, Gowran, Co. Kilkenny

In accordance with the decision of the Council on 17th January 2022, a notice was published stating that Kilkenny County Council proposed to declare the road in the schedule hereunder to be a public road in accordance with the provisions of Section 11 of the Roads Act 1993 in order to facilitate the taking in charge of the estate in accordance with Section 180 of the Planning & Development Act 2000, as amended by Section 59 of the Planning & Development Act 2010.

Written representations or objections in relation to the taking in charge were invited from the public, however none were received. A schedule of works has been prepared and issued to internal service areas for costing. Works to bring the estate to taking in charge standard will be procured and arranged by the planning authority and funded from the bond. The road is considered to be of a public utility, and there are little or no financial implications in taking this estate in charge.

Kilkenny County Council is currently paying for the maintenance of the private well which serves The Paddocks (& this well also serves Bradóg Way). The maintenance arrangements for the well will remain in place until such time as the Gowran - Goresbridge - Paulstown scheme is upgraded. The private wastewater infrastructure will remain the responsibility of the residents.

I therefore recommend that Kilkenny County Council resolve to take the estate in charge and that the roads be declared public roads and entered into the roads schedule of Kilkenny County Council.
