This arrangement with a company operating on a monopoly basis is not fit for purpose and should be discontinued with a view to opening up a tendering process for accredited garages in Ireland similar to the DOE process that currently provide a quality service to the public for testing commercial vehicles. The carrying out of a car test on private vehicles over 4 years is mandatory and the government have a duty of care to the public to make adequate provision I the delivery of this service. This proposal would also have the potential to provide employment at local level for many people and provide enhanced opportunities for apprenticeships."
