# (i) Plean Sábháilteachta ar Bhóithre - Road Safety Plan

Mr. Seamus Kavanagh, Senior Engineer gave a PowerPoint Presentation on the Road Safety Plan 2022 to 2030.

In his Presentation he gave an overview on the following:

- Road deaths in Ireland per million inhabitants for 2012 and 2022 compared to a number of European countries.
- Long-term fatality trend.
- Fatalities in Ireland for 2018 to 2023.
- Fatalities per County and per road users.
- Five fatalities in Kilkenny in 2023, 178 in Ireland.
- Vision for the Plan zero road deaths and zero injury by 2050.
- Targets for reduction by 2024 and 2030.
- Safe System approach 7 Intervention Areas.
- Actions Safe Roads and Roadsides.
- Example of Road Improvement in County Kilkenny and Low Cost Accident Schemes.

He advised that the Road Safety Plan has been presented to the JPC and SPC2. SPC2 has recommended approval to the Plenary Council.

- Realignment of N77 National Secondary Road
- Courtesy Crossings not effective.

- Improvements on Ring Road, Kilkenny.
- Use of scooters on the roads no high viz vests.
- Improvement required on N25.
- Changes in signage drivers complacent with existing signage.
- Meeting with TII in person at a Council Meeting.

Mr. Seamus Kavanagh responded to the issues/concerns raised by the Members. He advised that the Council will be carrying out a campaign in early January on the new speed limits. He stated that funding in Kilkenny is quite good when compared to other counties. The TII and Department of Transport have funded a full-time Safety Engineer and this is very welcome. The Council liaises with the Gardaí in relation to road improvements and other road issues. Request will be sent to TII for their attendance at a Council meeting.

- Overview of the South East Homelessness Consultative Forum.
- Homeless Co-Ordinator's role in County Kilkenny.
- Services offered by the Homeless Prevention and Support Worker.
- Policy context for the service.
- Funding provided for the service.
- Key Performance Indicators.
- Units available in County Kilkenny for Homeless Service users.
- Challenges facing the provision of the service and the number of homeless presentations.

Cllr. Eugene McGuinness asked if Kilkenny was in a position to offer accommodation to all those who presented as homeless.

Cllr. David Fitzgerald complemented the Housing staff on the delivery of a much needed and challenging service. He said that Kilkenny does not have a high number of rough sleepers compared to other urban areas across the Country.

Ms. Mary Mulholland and Mr. Michael Leahy responded to the query raised.

It was proposed by Cllr. Eugene McGuinness, seconded by Cllr. David Fitzgerald and agreed that:

"We the Members of Kilkenny County Council approve the Draft Southeast Regional Homeless Action Plan 2023-2026, as circulated."

# (i) Straitéis Turasóireachta Chill Chainnigh 2023-2028 Kilkenny Tourism Strategy 2023-2028

Mr. Sean McKeown presented the Tourism Development Strategy & Action Plan for 2023-2028. He advised the Members that this is a Five Year Plan and has been prepared in consultation with SPC1. Public Consultation was also undertaken and engagement with Fáilte Ireland in the drafting of the Strategy. The Plan sets out the principle activities to be undertaken by the Council to achieve the following five objectives:

- (i) Destination Marketing
- (ii) Destination Management
- (iii) Infrastructure Development
- (iv) Partnership Working
- (v) Festival & Event Support.

He noted that 20% of the labour force in Kilkenny is employed in hospitality. The Strategy is to attract visitors to Kilkenny and to stay longer in Kilkenny, make it easier to get around and ensure sustainable principles are at the core of all tourism activity in Kilkenny. Mr. Sean McKeown recommends to the Council the adoption of the Strategy.

# 11. Fógraí Rúin - Notices of Motion

#### 17 (23) Cllr. David Fitzgerald

It was proposed by Cllr. David Fitzgerald, seconded by Cllr. Michael Doyle and agreed that:

"Kilkenny County Council to prepare a structural buildings conservation report as a first step to repairing, stabilising and conserving Woodstock House and to put a plan in place to repurpose this important tourism, cultural and historical asset".

Cllrs. David Fitzgerald, Michael Doyle, Mary Hilda Cavanagh and Joe Malone spoke on the Motion. Members expressed concerns on the current state of the remaining part of the house which was burnt down during the War of Independence. The structure needs to be examined and a decision is required on repurposing the structure.

Mr. Sean McKeown advised that in the interest of health and safety fencing was erected. The Council made an application for funding to Fáilte Ireland in 2019 but was unsuccessful. The Council are currently preparing an application for funding to stabilise the house. Conservation Specialist has been engaged to assist with the application.

Kilkenny County Council has invested significant funds in the restoration of the Gardens and Trails in Woodstock. A Route Option Report is underway to explore options for links to the Greenway and discussions are ongoing with Coillte in relation to further development on land in their ownership.

It was proposed by Cllr. Mary Hilda Cavanagh, seconded by Cllr. Fidelis Doherty and agreed that the following Notice of Motion from Clare County Council be taken as read and noted.

#### 42 (23) Clare County Council

"Today I want to encourage all of you to urge the Minister for Finance to take immediate action in introducing Primary Medical Certificates (PMCs) to all individuals with physical disabilities. I also call upon the members of the Seanad to initiate a commencement debate emphasizing the critical necessity for the Minister for Finance to issue PMCs to all those with physical disabilities.

*In recent weeks, I have received numerous heartfelt communications from individuals across our county.* These messages have come from parents and family members who share a common belief with me - that the widespread issuance of PMCs to individuals with physical disabilities could significantly enhance the quality of life for these individuals and their families. I understand this is not the first time this issue has been brought to the attention of the Minister, or the Ministers before him, and undoubtedly it will continue to be raised with the ministers who follow.

People born with physical disabilities often endure a multitude of health challenges, including heart problems, early onset arthritis, chronic pain, conditions such as Lupus, MS, Syringomyelia, visual and hearing impairments, bronchial issues, and a compromised immune system, to name just a few.

The introduction of PMCs for all those affected would go a long way in aiding families by providing improved access to transportation for hospital and doctor visits, granting individuals a modicum of independence necessary to maintain their spirits.

The current criteria for obtaining a Primary Medical Certificate is archaic and no longer applicable to the myriad of complex disabilities diagnosed on a daily and weekly basis. A Primary Medical Certificate should be a top priority, not an arduous and exasperating process.

We must recognise that individuals with disabilities deserve our unwavering support and assistance. They should not be treated as second-class citizens but should receive the necessary support to help them navigate each day with reduced pain and improved quality of life. A Primary Medical Certificate is a vital document that confirms severe and permanent disability.

The existing criteria, defined in the Finance Act 2020, no longer suffice. We must advocate for a radical overhaul of the Finance Act in 2024 to adapt to the evolving needs of individuals with disabilities. Our government must actively champion the rights of people with disabilities and provide more than mere table scraps in terms of support and recognition. It is crucial that we facilitate the application process for a Primary Medical Certificate through Local Health Offices.

In conclusion, let us unite in our resolve to make a difference in the lives of individuals with physical disabilities by pushing for the introduction of Primary Medical Certificates. Let us demonstrate our commitment to equality, compassion, and progress for all members of our society."

Mr. Lar Power, Chief Executive thanked the Elected Members for their assistance throughout the year and wished them all a joyous, healthy and happy New Year.
