- (i) Cllr. Joe Malone requested that an invitation be extended to Deputy Kathleen Funchion to address the Council before she takes up her MEP role. Cllr. Michael McCarthy advised that this will be referred to the Corporate Policy Group for consideration.
- (ii) Cllr. Seán Ó hArgáin asked that the Irish Language be used more at the meetings and across the Council.

That concluded the business of the meeting.
