Dear Councillor,

It is a requirement of the Local Government Act 2001, as amended by Section 59 of the Local Government Act 2014, that the Council established an Audit Committee within 3 months of Polling Day for the newly Elected Council.

Article 4 of the Local Government Audit Committee Regulation 2014 sets out the composition of the Committee as follows:

The Audit Committee shall consist of five members and

- shall include not less than three External Members,
- not more than two serving or retired Elected Members and
- two or more persons having knowledge or experience in Finance, Audit or Accounting.

The Audit Committee's role is to support the Council by providing an independent assessment of the activities of management in controlling the Council and the quality of the Risk Management, Financial Reporting, Financial Management and Internal Audit.

The appointment of three External Members was discussed at the Corporate Policy Group and the Corporate Policy Group, having consulted with the Chief Executive, is nominating the following as members of the Audit Committee:
