1. Introduction

This report forms part of the statutory procedure for the making of Amendment 1 to the Callan Local Area Plan 2019-2028.

This report addresses the submissions received during the 6 week public consultation period, from the 15th May to the 26th June 2024, in relation to the Proposed Amendment.

The purpose of this report is to:

- summarise the written submissions/observations received,
- set out the Chief Executive's response to the issues raised and;
- make recommendations to the Elected Members on the issues arising from the consultation process.

This report is being furnished to the Elected Members of Kilkenny County Council in accordance with Section 20 (3) of the Planning and Development Act 2000, as amended, for their consideration.

1.1 Proposed Amendment

This proposed Amendment is intended to change the zoning on three sites in the Clashacollare area of Callan, as follows:

- a) An area of almost 1.3 hectares, zoned as New Residential has been developed as a significant tranche of public open space. This amendment proposes to rezone this area to Open Space/Green infrastructure, to reflect its current use.
- b) To ensure sufficiency of available land for development, an area of 0.77 hectares is proposed for rezoning from Agriculture to New Residential.
- c) To reflect the current development constructed (and remaining site under construction), an area of 1.2 hectares is proposed for rezoning from Agriculture to Existing Residential.

1.2 Details of Public Display

KK- C258- 2	Uisce Éireann	1.All new residential and commercial/industrial developments wishing to connect to Uisce Éireann (UÉ) network are to be assessed on a case-by-case basis through the New Connections process, which will determine the exact requirements in relation to network and treatment capacity. 2.Capacity registers are subject to change at any time and are published annually, UÉ recommend that a footnote be added to any references to the capacity registers in the Proposed Amendment No. 1 to advise of this, particularly with reference to Sections 1b and 1c of the SEA Screening document which reference the capacity registers directly.

A footnote will be added to the SEA screening document to advise that the water services capacity registers are subject to change at any time and published annually.
