(b) Pleanail - Planning

(i) Nuashonrú ar Athruithe ar Phlean Forbartha Cathrach & Contae Update on Variations to City & County Development Plan

Cllr. Mary Hilda Cavanagh proposed an amendment to the proposed Variation 2 to reflect what was proposed by the Elected Members at the July meeting by way of a Notice of Motion. This was seconded by Cllr. Andrew McGuinness.

Mr. Tim Butler explained to the Meeting that what is proposed in the amendment is not what was out on public consultation as part of Variation 2 to the City and County Development Plan 2021. The proposed amendment would have to go through the public consultation process which included consultation with the Office of the Planning Regulator (OPR) and it is likely that the OPR will not accept this proposed variation. It is a material change to what was put on public display for Variation 2.

Mr. Denis Malone advised that the Elected Members have the following options in relation to the Variation that is before the meeting:

- Adopt the Variation as presented.
- Refuse the Variation or
- Amend the Variation.

He also stated that what is proposed in the amendment by Cllr. Mary Hilda Cavanagh is a different variation.

It was proposed by Cllr. Mary Hilda Cavanagh and seconded by Cllr. Peter 'Chap' Cleere and agreed:

"that the meeting be adjourned for 10 minutes to allow members discuss the matter".

Following the ten minutes, it was further proposed by Cllr. Michael Delaney, seconded by Cllr. Seán Ó hArgáin and agreed:

(i) Plean Cothabhála Geimhridh 2024/2025 – Winter Maintenance Plan 2024/2025.

Mr. Seamus Kavanagh presented his report on the Winter Maintenance Plan for 2024/2025. He advised the Members that the service delivery target is to keep Priority 1 and 2 network frost/ice free over the 24 hours/7 days a week. The total length of the network is 430km. Four vehicles are deployed to deliver this service.

Elected Members will be given an opportunity at their Municipal District Meeting to discuss the proposed Priority 3 Routes. These routes will receive treatment during periods of particularly severe weather.

Contributions were received from Cllrs. Pat Fitzpatrick and Tomás Breathnach, in relation to the following:

- Keeping roads open Cllr. Pat Fitzpatrick.
- Liaising with the school transport authorities Cllr. Tomás Breathnach.

Mr. Kavanagh responded to the queries raised by the Members.

(ii) Luasteorainneacha Nua Tuaithe - New Rural Speed Limits.

Mr. Seamus Kavanagh advised the Members that the new Rural Speed Limits will come into effect at the end of November 2024 which will see roads with 80km speed limit reduced to 60km. Signs and poles will be delivered shortly and the Council have received an allocation of €330,000 towards the cost of erecting signs.

Mr. Seamus Foley gave a brief powerpoint presentation to the meeting
outlining the Projects coming on stream – Street and Park, Boardwalk,
Brewhouse Square (copper tank), Cultural Hub, Engineer's Block,
Watergate Theatre.

Mr. Tony Lauhoff then followed with a presentation on the Abbey Quarter Partnership Projects – Brewhouse, Building 7, Hotel and residential detailed assessment of feasibility.

Elected Members thanked Mr. Foley and Mr. Lauhoff for their presentations.

Contributions were received from Cllrs. Seán Ó hArgáin, Tomás Breathnach and Eugene McGuinness, in relation to the following:

Mr. Foley responded to the queries raised by the Members.

(ii) Kilkenny Vintners Seisiún Faisnéise – Briefing from Kilkenny Vinters in relation to local Festivals.

Anthony Morrisson and Eddie Langton from Kilkenny Vintners spoke to the meeting in relation to the benefits of local Festivals to the economy in Kilkenny City and County and the need for Kilkenny to remain competitive with other counties. They appealed for extra funding to be put in place for the Festival and Events Grants scheme to support festivals going forward.

Cllr. Andrew McGuinness thanked Mr. Morrisson and Mr. Langton for their presentation and supported their request for increased funding.

The bodies of these five members of the Irish National Invincibles lie beneath the paving slabs of the yard where they were executed in 1883 for their part in the Phoenix Park assassinations. The families of the five men are represented by the National Graves Association and the wish of the families is for their relatives remains to be exhumed from Kilmainham jail and reinterred in consecrated ground at Glasnevin cemetery."
