The Review



- ➤ It is a Statutory Requirement under the Local Government (Audit Committee) Regulations 2014 that the Audit Committee undertake a review of its own effectiveness and report to the Local Authority on its findings.
- The Review of Effectiveness was undertaken by the Committee in 2024 to cover the 2019-2024 term of the Audit Committee.
- ➤ This review examined in detail the Effectiveness of the Audit Committee in carrying out its Statutory Functions.
- The review was approved by the Audit Committee at their meeting on 9th September 2024.

What are the functions of the Audit Committee?

- ➤ To review financial and budgetary reporting practices and procedures within Kilkenny County Council.
- ➤ To foster the development of best practice in the performance by Kilkenny County Council of its Internal Audit Function.
- ➤ To review any audited statement, Auditor's report or Auditor's special report in relation to Kilkenny County Council and assess any actions taken within the Council by the Chief Executive in response to such a statement or report and to report to the Council on its findings.
- ➤ To assess and promote efficiency and value for money with respect to Kilkenny County Council's performance of its function.
- > To review systems that are operated by the Council for the management of risk.

The Audit Committee



- ➤ The Audit Committee Charter and Work Programme is approved by the Members of Kilkenny County Council annually.
- > The Committee meet quarterly.
- ➤ Kilkenny County Council's Internal Audit Plan is approved by the Audit Committee.
- ➤ As Internal Auditor for Kilkenny County Council, I present Internal Audit Reports to the Committee quarterly for review. The Audit Committee closely monitors the implementation by Management of the recommendations contained in these Audit Reports.
- ➤ The Chief Executive and Management Team present on their respective areas of responsibility to the Audit Committee.
- > The Local Government Auditor meets privately with the Audit Committee annually.

Conclusion



It is recognised that Audit Committees play a crucial role in the governance framework of Local Authorities, particularly in the context of increased Public Sector accountability. The Review of Effectiveness of the Audit Committee is essential to ensure that the Audit Committee is meeting their Statutory obligations and promoting best practice within Kilkenny County Council.
