Proposed by Cllr Andrew McGuinness and seconded by Cllr Pat Dunphy and agreed
"That Minutes of Annual Meeting of Kilkenny County Council held on Monday, 27th June,

Cllr Pat Dunphy requested that the representatives of Macra na Feirme attend the September Meeting. It was agreed to allow a short presentation to Members in advance of the Council Meeting between 2.15pm to 2.45pm.

2. (a) Tithíocht & Díuscairt Eile - Housing & Other Disposal

- (i) It was proposed by Cllr. Pat Dunphy seconded by Cllr. Tomás Breathnach and agreed: "That, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest in land at Tower Road, Piltown, Co. Kilkenny (as identified on the attached map) to Shane and Selena Bourke, 1 Railway Close, Fiddown, Piltown, Co. Kilkenny for the sum of €185,000 (one hundred and eighty-five thousand euro) with each party being responsible for their own legal costs associated with the sale. Site area measures 0.420 ha. The Consent of the Minister for Housing, Local Government and Heritage is not required" (*Notice sent to Members on the 27th June, 2025*)".
- (ii) It was proposed by Cllr. Tomás Breathnach seconded by Cllr. Jenny Catt Slattery and agreed:

"That, in accordance with Section 183 of the Local Government Act, 2001, to dispose of its interest in two derelict properties being sold as one at Dunkitt, Kilmacow, Co. Kilkenny (as identified on the attached map) to John McNicholas & Joe Culleton, CULMC Construction, Bridgefield, Tramore, Co. Waterford for the sum of two hundred and thirty five thousand euro (€235,000) with each party responsible for their own legal costs associated with the sale. The combined site area measures 1.01 acres (0.41 Ha). The Consent of the Minister for Housing, Local Government and Heritage is not required" (*Notice sent to Members on the 10th July, 2025*).

- (iii) It was proposed by Cllr. Deirdre Cullen seconded by Cllr. The Consent of the Minister for Housing, Local Government and Heritage is not required. The land area measures 0.04 Ha/0.1 acre." (Notice sent to Members on the 10th July, 2025).
- (vii) It was proposed by Cllr. Michael Doyle seconded by Cllr. Fidelis Doherty and agreed: "That, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest in land at Coolmore, Knocktopher, Co. Kilkenny Plot 206z.2- as identified on the attached map to William Coogan, Ballynooney, Mullinavat, Co. Kilkenny and Mairead Coogan, Cappagh House, Cappagh, Inistioge, Co. Kilkenny. The Consent of the Minister for Housing, Local Government and Heritage is not required. The land area measures 0.035 ha/0.086 acre." (Notice sent to Members on the 10th July, 2025).

(b) Pleanail - Planning

(i) Part 8: Site Works at 18 Skeaugh, Callan, Co Kilkenny

It was proposed by Cllr. Deirdre Cullen, seconded by Cllr. David Fitzgerald and agreed to proceed with the proposed development.

"We the Members of Kilkenny County Council approve the Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, for the demolition of existing single storey side and rear extensions (approx. 18.5sqm), the demolition of a shed to the rear of the site (approx. 34sqm) and the construction of a new part 2 storey, part single storey extension (77sqm) to provide a 4-bedroom house with an accessible ground floor bedroom, bathroom & living accommodation, a new Domestic waste water treatment system and percolation area with all associated site works at 18 Skeaugh, Callan, Co. Kilkenny, R95 A9X8."

(ii) Proposed Variation 5 to City & County Development Plan 2021 Castlecomer Settlement Plan

Cllr. Pat Fitzpatrik proposed an amendment/alteration to Variation 5 of the City & County Development Plan 2021 – Castlecomer Settlement Plan seconded by Cllr. Mary Hilda Cavanagh and agreed:

"That Kilkenny County Council rezone to residential the lands to the West of Oak Hill as sought by Submission references KK-C322-13 and KK-C322-15 to the Variation) which was previously zoned in the LAP 2018".

It was explained to the Members that the relevant environment and flood assessments would be undertaken, and a further public consultation would take place on the proposed amendment only before reverting to Council for consideration.

(iii) Taking in Charge: [TC 184] Cnoc Baun, Ballyfoyle Road, Kilkenny.

Proposed by Cllr. Andrew McGuinness, seconded by Cllr. Eugene McGuinness and agreed:

"That the County Council of the County of Kilkenny, in exercise of the powers conferred on them by Section 11 of the Roads Act,1993 and in compliance with Section 180 of the Planning & Development Act, 2000 as amended by Section 59 of the Planning & Development Act 2010, hereby declares the road listed in the Public Notice and listed below, to be a Public Road."

Estate: TIC184Baun/Cnoc Baun, Ballyfoyle Road, Kilkenny

(iv) Taking in Charge: [TC 181] Rathullord Phase 3, Kilkenny.

Proposed by Cllr. Joe Malone seconded by Cllr. Seán Ó hArgáin and agreed.

"That the County Council of the County of Kilkenny, in exercise of the powers conferred on them by Section 11 of the Roads Act, 1993 and in compliance with Section 180 of the Planning & Development Act, 2000 as amended by Section 59 of the Planning & Development Act 2010, hereby declares the road listed in the Public Notice and listed below, to be a Public Road."

Estate: [TIC181] Rathullord (Phase 3), New Orchard, Bonnettsrath Road, Co Kilkenny

(c) **Boithre** _ **Roads**

(i) Update on Graignamanagh - Tinnahinch Flood Relief Scheme.

Andrea Brogan of Ayesa provided an update on the Graignamanagh-Tinnahinch Flood Relief Scheme and outlined the Background to the Scheme. The Programme Schedule which is currently at Stage II − Planning entailing; Stakeholder Consultation, Option Selection Process, Key Environmental Considerations, the Overall Scheme and Current Actions with a current overall estimated cost of €22m.

Contributions were received from Cllr. Deirdre Cullen, Cllr. Brian Cleere, Cllr Michael Doyle, Cllr Pat Dunphy and Cllr. Tomas Breathnach.

Issues raised:

- In relation the Thomastown/Inistioge Schemes, removal of sand and silt from the river.
- Timeframe for Part 10.

It was confirmed that the role of Ayesa was specifically in relation to the Graiguenamanagh – Tinnahinch Flood Relief Scheme and that the other schemes were being worked through. It was further confirmed that the project was 100% funded through the OPW and that it is now moving into the Part 10 Planning process.

The Cathaoirleach thanked Ms. Brogan for her informative presentation.

(ii) N25 Glenmore to Luffany Speed Limit Review

Mr. Seamus Kavanagh, Senior Engineer provided an update on the N25 Glenmore to Liffany Speed Limit Review, stating that the proposed speed limit change was from 100km/h reduced to 80km/h from Luffany roundabout to 500m north of Ballinclare Junction (L7522). Mr. Kavanagh noted that the speed limit reduction would be managed through an amendment to the 2023 Special Speed Limit Bye-Laws, noting that the pre-draft consultation phase closed on the 8th July and the Amended Bye-Laws Public Consultation will open on 23rd July until 4pm on the 4th September. The Proposals are to be sent to the Garda Commissioner for observations and consent will be required from Transport Infrastructure Ireland which will be required prior to bringing Bye-Laws for consideration of the Members.

It was proposed by Cllr. Fidelis Doherty seconded by Cllr. Ger Frisby and agreed:

"That Kilkenny County Council agrees to go out to public consultation with a proposal to reduce the speed limit from 100km to 80km on N25 Waterford to Glenmore road from to Luffany Roundabout to 500m north of Ballinclare Junction (L7522)."

Cllr. Frisby noted that a very positive meeting had taken place with Minister Darragh O'Brien on 16th July on this matter and a large number had attended the public meeting.

(d) Timpeallacht- Environment

Section 85 - Carlow/Kilkenny Dog Shelter at Paulstown, Co Kilkenny.

It was proposed by Cllr. Eugene Mc Guinness, seconded by Cllr. Michael Doyle and agreed:

"To extend the Section 85 Agreement currently in place with Carlow County Council for the Operation of the Carlow/Kilkenny Dog Shelter in Paulstown until 31st August 2026."

(e) Airgeadas - Finance

Capital Programme 2025-2030

Mr. Martin Prendiville provided an update on the Capital Programme 2025 – 2030 and outlined that members are required to adopt a 3-year rolling programme annually. Mr. Prendiville presented a 6-year capital programme with a total estimated spend of \in 1.105 billion, with match funding required of \in 104.6m, with a current funding shortfall of \in 59.2m of which a signification of same will be funded from Development Contributions and opportunities for additional grant funding to be explored.

Contributions were received from Cllr. Mary Hilda Cavanagh, Cllr. Andrew McGuinness, Cllr. Michael Doyle, Cllr. David Fitzgerald and Cllr. Sean O'hÁrgáin.

It was agreed to arrange a further workshop on the Development Contribution Scheme on Monday 28th July at 3.30pm.

It was proposed by Cllr. Andrew McGuinness and seconded by Cllr. Michael McCarthy

"That the Capital Programme for the 6 Year period 2025-2030 be adopted by the Members of Kilkenny County Council."

This is subject to funding and to be reviewed annually.

(f) Pobal & Cultúr - Community & Culture

A report on the CCFCS grant approvals was circulated to all members.

It was proposed by Cllr. Seán Ó hArgáin, seconded by Cllr. Michael Mc Carthy and agreed:

"That the allocation of funding totalling €250,000 to 12 projects as outlined in the report be approved."

(i) Chief Executive Monthly Report. - Noted as read.

Cllr. Sean O'hÁrgáin raised the recent River Nore health concerns and it was explained that a press release had issued to all members in relation to ongoing river testing and that it is not safe to bathe until tests are clear. Efforts to identify the source will continue and that Members would be kept updated on same.

(ii) Appointment of Member to Watergate Theatre Company.

It was proposed by Cllr Andrew Mc Guinness, seconded by Cllr. Pat Fitzpatrick and agreed:

"That Cllr Joe Malone be appointed as a member to the Watergate Theatre Company.

(iii) Appointment of Chairperson to SPC 1

It was proposed by Cllr. Fidelis Doherty, seconded by Cllr Pat Dunphy and agreed:

"That Cllr. Michael Doyle be appointed as Chairperson to SPC1".

15 (25) Cllrs. Pat Dunphy, David Fitzgerald, Mary Hilda Cavanagh, Joe Lyons, Michael Doyle, Fidelis Doherty and John Brennan

It was proposed by Cllr. Pat Dunphy and seconded by Cllr. Mary Hilda Cavanagh and agreed that the motion be submitted in the name of all Councillors.

"To call on the Minister for Climate, Environment and Energy, Minister Darragh O'Brien to urgently consider the introduction of a grant scheme to support homeowners in testing their homes for Radon Gas and safeguarding against the impacts. Radon is a colourless, odourless radioactive gas and is recognised as the second leading cause of lung cancer after smoking. Despite its dangers, its presence is entirely preventable through proper testing and mitigation.

Given the serious public health risks associated with prolonged exposure, it is essential that the Department provides financial assistance to encourage widespread testing. We urge the Minister to respond positively and act swiftly in making such support available to homeowners."

16 (25) Cllr. John Coonan & Cllr. Seán Ó hArgáin

It was proposed by Cllr. John Coonan and seconded by Cllr. Sean O' hArgáin and agreed that the Council seek a suitable location for a BMX and pump track in Kilkenny.

"Kilkenny County Council recognises the excellent work being done to promote cycling as a leisure activity and as a means of travel for commuting and tourism purposes in our City and County. Recognising the growing demand for cycling as a leisure activity, particularly off-road cycling, this Council commits to investigating the provision of and give positive consideration to a BMX and pump track at Kilkenny Countryside Park Dunmore or another suitable location, which would also incorporate a safe space for beginner cyclists."
