#### 2. (a) Tithíocht & Díuscairt Eile - Housing & Other Disposal

It was proposed by Cllr. Tomás Breathnach, seconded by Cllr. Fidelis Doherty and agreed:

"That, Notice is hereby given, that at a meeting of the Council to be held after the expiration of 10 days from the date of this notice, it is the intention of Kilkenny County Council, that, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest in land at The Nite Cap, Kilmacow, Co. Kilkenny, (as identified on the map) to Shane Molloy, Wildflower Cottage, Boley Hill, Fethard-on-Sea, Co. Wexford for the sum of €153,000 (one hundred and fifty-three thousand euro) with each party being responsible for their own legal costs associated with the sale. Site area measures 0.38ha. The Consent of the Minister for Housing, Local Government and Heritage is not required."

# (b) Cuid 8 Pleanáil – Development of a Cultural Hub at the Abbey Quarter Squash Courts, Kilkenny 01/25

Mr. Martin Prendiville provided an overview of site's acquisition by the Council and the decision to retain the Brewhouse, Mayfair and Squash Courts buildings. The Squash Courts will be developed into a Cultural Hub and managed as an annex to the Watergate Theatre.

Mr. Prendiville confirmed that 75% grant funding has been secured under the Urban Regeneration and Development Fund (URDF) with the remaining 25% provided by the Council.

Mr. Seamus Foley, Senior Engineer, presented the proposed development, highlighting the following points:

- Background on the proposed use as a Cultural Hub (Rehearsal Space).
- Site Location details.
- Key Elements of the proposed development.
- Part VIII Planning Public Consultation.
- Submissions received and topics addressed in submissions.
- Recommendation by Chief Executive for approval by Elected Members.

The majority of Elected Members expressed their support for the project noting that it will be a valuable addition to the Watergate Theatre and elevate its offering.

Cllr. Maria Dollard acknowledged the efforts of Kilkenny County Council staff in advancing this project, recognising its significance for the Arts Community in Kilkenny. However, she expressed disappointment regarding the facility's accessibility, noting that the first floor space was not accessible to everyone.

Cllr. Seán Ó hArgáin, in support of the project, requested further clarification regarding the footprint required for the installation of a lift.

Cllr. David Fitzgerald expressed his inability to support the development due to the lack of provision for the Kilkenny Squash Club, which lost its permanent home in 2022. He noted that the expressions of interest for the current site occurred during COVID, causing the Squash Club to miss their opportunity to submit an expression of interest. He welcomed the Council's recent purchase of the Hughes Family home for further redevelopment as part of the Watergate Theatre.

Cllr. John Coonan enquired about the possibility of making adjustments to the proposal to make it universally accessible.

Mr. Martin Prendiville addressed the points raised by Cllr. Maria Dollard and Cllr. David Fitzgerald noting:

- 50% of the space upstairs would become unusable if a lift was installed. There was only one location where a lift could be installed.
- The majority of usable space is downstairs and designed with full accessibility in mind.
- The criteria for Expression of interest were broadened to allow for sports Clubs to submit a proposal, which did not occur.
- The Council deemed the Watergate Theatre proposal viable proposal and meeting all criteria.
- The Council does not currently have possession of Hughes site, but will collaborate with the Watergate team on future development once possession is secured.
- The Hughes site does not have sufficient space to accommodate the space being developed in the cultural hub along with the other requirements that the Watergate Theatre have.

Mr. Seamus Foley responded regarding the lift provision, explaining that a lift would service a room of 31m<sup>2</sup>, whereas the standard requirement is when the space is over 200m<sup>2</sup>. He clarified that a lift is not justified as all services for the proposed use as a cultural hub are provided for on the ground floor.

Following a further discussion, the Cathaoirleach called for a vote on the proposal and asked for a show of hands.

On a show of hands 19 members voted in favour and 2 (Cllr David Fitzgerald and Cllr Maria Dollard) voted against the following resolution:

"We, the Members of Kilkenny County Council approve the Part 8 in accordance with Section 179 of the Planning and Development Act 2000 as amended and Part VIII of the Planning and Development Regulations 2001, to the development of Cultural Hub at the former Smithwicks Brewery Squash Court Building, Abbey Quarter, Kilkenny."

The resolution was carried by 19 votes to 2 votes.

Mary Mulholland, Director of Services, acknowledged the Council's disappointment that funding was not secured to progress the N24 and N25 roads projects in 2025. She also recognised the public's concern over the lack of progress. She explained that the issues surrounding these projects are complexed and layered. A Workshop was held with Elected Members prior to this meeting and Kilkenny County Council committed to ensuring that both projects are included in the 2026 funding. Meanwhile, the Council will focus on other measures to improve the situation and continue working towards the completion of both schemes.

"That this Council write to the Minister for Children, Equality, Disability, Integration and Youth, expressing our deep concern over the critical shortage of community-based childcare services in the Kilkenny-Carlow area. Families are struggling with

unaffordable private childcare costs, highlighting the urgent need for a publicly funded Early Years Education System. We call on the Government to prioritise investment in affordable, high-quality, community-based childcare to establish sustainable early years and after-school services. This measure would support working families who are finding it difficult to meet the expense of childcare services."

Cllrs. Pat Dunphy, Seán Ó hArgáin and John Coonan spoke in support of this Motion.

### 10(25) Cllrs. Ger Frisby, Jenny Catt Slattery, Pat Dunphy, Fidelis Doherty and Tomás Breathnach.

It was proposed by Cllr. Ger Frisby, seconded by Cllr. Pat Dunphy and agreed that:

"that the Members write to the Minister for Transport in support of Waterford Airport in its endeavours to secure funding from the Department to further develop the airport given its strategic importance to the economic development of the Southeast Region and in particular to enable business and tourism growth and development in County Kilkenny."

Cllrs. Ger Frisby, Pat Dunphy, Tomás Breathnach, Michael Delaney and Jenny Catt Slattery spoke on this Motion in support of the development of Waterford Airport for the growth of the Southeast Region.
