- Libraries are an invaluable resources for those who don't have somewhere to study or access to WIFI.
- Programme of Exhibitions in Mayfair is exceptional showcasing Artists work.
- Carniege Library crucial to the built heritage of Kilkenny Local Studies Proposals.
- Enquired about extending opening hours in Libraries in City and across the County for exam students.
- Fantastic to see kids reengaging with Library.
- Library Service helping to build communities.
- Suggestion that informative presentation on smartphone usage be delivered to Elected Members to enhance awareness and understanding.

It was proposed by Cllr. Seán Ó hArgáin, seconded by Cllr. John Brennan and agreed that:

"That the Library Service Delivery Development Plan 2025-2029 is hereby approved by the Members of Kilkenny County Council."

Mr. Martin Prendiville advised the meeting that the Audit for the Year 2024 had now been completed by the Local Government Auditor and was circulated to the Members. There was no change to the Annual Financial Statement [AFS] following the audit.

Martin Prendiville confirmed that the expenditure for the year was €312.4m which was €21.3m higher than the adopted budget. The surplus for the year was €31,775. Mr. Prendiville referred Members to Page 24 of the AFS which outlined details of the expenditure variances for each Service Area along with the relevant income streams.

Mr. Prendiville also presented the Local Government Auditors Report to the Members. He outlined the topics reported on by the Auditor and the replies provided by Management on those topics.

Contributions received from Cllrs. Maria Dollard, Eugene McGuinness, Seán Ó hArgáin, Pat Fitzpatrick & John Brennan in relation to the following:

- Loan Financing.
- Funding of the Capital Account.
- Delays on the PLEEP Project and implications of same.

Martin Prendiville and Tim Butler replied to the queries.

Mr. Prendiville advised that the sources of funding for all Capital Projects has to be identified in advance of committing to a Project. He advised that some loan finance would be drawn down before the year end to fund the PLEEP expenditure and for match funding for other capital projects. The Members have already approved their loans.

Tim Butler provided an update on the PLEEP Project. Kilkenny is the head authority on this project for a total of nine counties. A Section 85 Agreement is in place with the other eight Local Authorities.

Delays have been encountered and Kilkenny County Council is working towards completion of the project in a timely manner.

It was proposed by Cllr. Pat Dunphy, seconded by Cllr. Pat Fitzpatrick and agreed that:

### Amber Women's Refuge CLG Annual Report

Ms. Mary Mulholland, Director of Services highlighted the vital work carried out by Amber in Kilkenny and Carlow and expressed her appreciation for the dedication and commitment shown by the team in delivering these essential services.

Cllrs. Sean O'hArgáin & Maria Dollard agreed that it was important to support Amber as it provides a crucially important service to all in Kilkenny and Carlow.

Response noted.

- Suggestion to meet more frequently with Oireachtas Members and provide them with Notices of Motion to bring to relevant Departments.
- Questioned whether focus should move to more local issues.
- Recommendation to raise issue with Task Force on Local Government, AILG & LAMA.

### **Development Contribution Meeting**

Development Contributions meeting with Party Whips to take place from 2.00 p.m. to 3.00 p.m. on Monday, 6<sup>th</sup> October, 2025. Cllr. Tomás Breathnach asked that consideration be given to allowing each group to nominate two representatives to attend the Development Contributions meeting. This was agreed by all.

### **Special Meeting - Presidential Candidates**

Margo Hayes outlined the nomination process for candidates. It was agreed that a list of candidates, along with relevant information would be circulated to all Elected Members.

Seán Ó hArgáin proposed that any individual seeking to address the Council and request its support should be formally proposed and seconded by at least two Members. He also expressed surprise at the limited engagement from candidates with Elected Members.

Ms. Mary Mulholland, Director of Services explained that there is no set process for candidate nominations and each Local Authority has developed its own approach. It was agreed at CPG that the objective is to support the democratic process by providing an opportunity for as many potential candidates as possible to be heard and considered by the Chamber. A number of meetings have been scheduled on different dates, with decisions made on a County by County basis. The Council decided not to limit attendance to be fair to all.

Ms. Mulholland agreed to circulate a list of candidates to allow Members time to review in advance.

Cllr. Tomás Breathnach suggested that this matter should be reviewed when looking at Standing Orders and put a process in place for future.

Cathaoirleach Cllr. Mary Hilda left meeting and Cllr. Fidelis Doherty took over as Chair.

### 11. Fógraí Rúin - Notices of Motion

# 18 (25) Cllrs. Michael Doyle, Mary Hilda Cavanagh, Pat Dunphy, Fidelis Doherty, Joe Lyons, David Fitzgerald and John Brennan

Proposed by Cllr. Michael Doyle, seconded by Cllr. Pat Dunphy and agreed:

"In the context of the lack of necessary municipal wastewater infrastructure in the vast majority of our towns and villages across the county we call on Kilkenny County Council to accept the principle of developer led modular wastewater plants in towns and villages where there is a demand, desire and need for development.

We further call on Minister for Housing, James Browne to direct Uisce Eireann to support the local authority in overseeing and ensuring the treatment systems are of acceptable standard, have acceptable maintenance plans and will be constructed in a manner whereby full connection will be possible to municipal plants when delivered."

Cllrs. Michael Doyle, Pat Dunphy, Maria Dollard, Seán Ó hArgáin, Jenny Catt Slattery & Deirdre Cullen spoke on this motion. Issues raised as follows:

- Biggest issue in rural Ireland is lack of development.
- A lot of funding has been given to Towns & Villages and CLÁR and while villages are looking well there is nobody living in them.
- Requested Department to come up with a plan to deliver necessary infrastructure to allow for rural development.
- Going to lose services that a rural Parish needs.
- Way of life in rural Ireland will be gone.
- Call on Executive to consider how the Council can deliver a solution for these areas.
- Serious issue with current waste water system.
- Variation proposed in the County Development Plan
- Concerns that the Council would be exposed to costs.

A discussion took place in relation to Members speaking on Notices of Motion.

Ms. Mary Mulholland referred to Standing Orders and advised that there would not be multiple speakers on Notices of Motion. She advised that Standing Orders clearly state that the Proposer and Seconder would speak on Motion with no other speaker facilitated. Other speakers allowed only if there is an amendment to Motion.

If members want to change the process it can be brought to CPG and is a matter for members to decide.

Mr. Tim Butler, Director of Services replied as follows:

- 4 water supply schemes in County that do not have capacity for any additional houses.
- 15 small towns and villages which do not have capacity for any additional connections to those supplies.
- Significant environmental issue in Kilmanagh.
- Developer led infrastructure in Hugginstown causing significant environmental issues.
- 15 wastewater supplies that do not have capacity.
- Variation 4 bought to the Members early this year and submitted to Office of Planning Regulator who advised of significant impact on environment and question of who is going to maintain it.
- If that falls back on Local Authority it will have significant funding implications.
- As a Planning Authority we will go back to the OPR to see if we can agree a certain wording in relation to a developer led infrastructure if this is to happen we would have to know that it is not going to have an impact on the environment, that the developer will maintain. And that in time Uisce Eireann will take it in charge.

### a19 (25) Cllr. Brian Cleere

Proposed by Cllr. Brian Cleere, seconded by Cllr. Joe Sheridan and agreed:

"To introduce a 'Community Hedge Cutting Grant Scheme' to Kilkenny. This scheme will provide financial assistance to communities and local resident groups who wish to undertake overhanging trees and hedge cutting for safety reasons, and will also assist landowners to comply with their responsibilities under Section 70 of the 1993 Roads Act."

Cllr. Brian Cleere & Cllr. Joe Sheridan spoke on the Motion.

Ms. Mary Mulholland, Director of Services advised that responsibility for landowners to ensure that roadside hedges on private property are trimmed is listed in the Act as the responsibility of the land owner. She advised that to propose the Notice of Motion would be contrary to our responsibilities under the Act and it would be difficult to make provision for it under our Roads Programme or to fund it from 2026 Programme.

Ms. Mulholland advised that this would have a huge impact on the Rural and Local Roads Budget and where this is happening in other local authorities they are providing funding from their Roads Programme annually.

### 20 (25) All Elected Members

Proposed by Cllr. Pat Dunphy, seconded by Cllr. John Brennan and agreed:

"To ask the Minister for Arts, Media, Communications, Culture and Sport, Patrick O'Donovan, to provide the  $\in$ 15 million (current annual funding is  $\in$ 10 million)  $\in$ 5 million increase sought by the Irish Postmasters Union to safeguard the Post Office Network. This support is vital to keep Post Offices, key community and financial service hubs, open, as the current model is unsustainable. A recent Grant Thornton report warns that without this funding, up to one-third of rural post offices could close by 2026."

Cllrs. Pat Dunphy & John Brennan spoke in support of this Motion.
