That, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest in land at Crowbally, Mullinavat, Co. Kilkenny – as identified on the attached map - to Patrick Thomas Gaule, Crawn, Kilmacow, Co. Kilkenny for the sum of  $\in$ 1,000 with each party being responsible for their own legal costs associated with the sale. Plot areas combined measure 0.8 acre. The Consent of the Minister for Housing, Local Government and Heritage is not required."

(i) Cuid 8/Part 8: Kilkenny Local Studies Hub and Public Realm Enhancements at John's Quay, Kilkenny

It was proposed by Cllr. Andrew McGuinness, seconded by Cllr. Mary Hilda Cavanagh and agreed:

That the Members of Kilkenny County Council approve the Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, to the proposed development comprising of the repurposing of the former Carnegie Library into a Kilkenny Local Studies Hub and Public Realm Enhancements at John's Quay."

Cllr Andrew McGuinness requested that it be reverted to residents only parking would be reinstated

#### (ii) Tuarascáil an Phríomhfheidhmeannaigh maidir le hAighneachtaí maidir le hAthrú Beartaithe 4 a ghabhann leis an bPlean Forbartha Cathrach & Contae 2021 Chief Executive's Report on Submissions to Proposed Variation 4 to the City and County Development Plan 2021

Denis provided the details in a presentation. Cllr. Jenny Catt Slattery expressed her disappointed as development cannot happen as there is not adequate wastewater treatment facilities which she feels is detrimental to rural villages. She was supported by Cllr. Pat Dunphy and Cllr. Michael Doyle.

Denis Malone, Senior Engineer responded to say that the policy must be framed so as to facilitate development and protect environmental assets. The challenge is to be pro-development while meeting legal obligations to protect ground water. He advised that the Chief Executive's recommendation provided the best way forward.

Cllrs. Pat Dunphy, Maria Dollard, Deirdre Cullen, Eugene McGuinness, David Fitzgerald. Tomás Breathnach, Fidelis Doherty, Ger Frisby and Mchael Doyle spoke on the variation and the issue of housing provision being hampered.

Cllr. David Fitzgerald asked if there is a list of priority towns so that Kilkenny is first in the queue when funding is made available. Tim Butler, Director of Services outlined that there is a priority list based on compliance (*where pollution is an issue*) demand for social housing and County Development Plan. We have prioritised fifteen villages with Bennetsbridge prioritised as the first. Cllr. Michael Doyle felt that demand is not a good metric as the lack of availability of housing is leading people to go elsewhere.

It was proposed by Cllr. Tomás Breathnach, seconded by Cllr. Jenny Catt Slattery and agreed:

"That the Members of Kilkenny County Council, having considered the proposal to make Variation 4A to the Kilkenny City & County Development Plan 2021 - 2027 under Section 13 of the Planning & Development Act 2000, as amended, and having considered the Chief Executive's Report as circulated on the 18th March, 2025, prepared in accordance with Section 13 (4) of the above Acts, outlining all submissions received on this proposal, the recommendations as set out in the Chief Executive's report, and with our decision made at a meeting of Kilkenny County Council held on the 24th March 2025, do hereby resolve to vary the current Kilkenny City & County Development Plan in accordance with Proposed Variation 4A."

A roll call vote was taken on the proposal not to vary the current Kilkenny City & County Development Plan in accordance with Proposed Variation 4B.

# (i) Scéim Ealaíne Poiblí - Public Art Scheme

Fiona Deegan, Director of Services introduced Mary Butler, Arts Officer. Ms. Butler provided a comprehensive overview of the scheme including the project to be funded.

Cllr. Maria Dollard spoke about how these Art Projects are the fabrics that hold communities together and how we understand ourselves is through the arts. She congratulated Mary Butler on the great work. Cllrs. Andrew McGuinness and David Fitzgerald also congratulated and thanked Ms. Butler. Mary acknowledged that conversation and engagement was key. Cllr. Tomás Breathnach enquired if the international dimension came through with the output of the assessments. Mary noted that all the artists are all Irish with an international reputation.

Dearbhala responded to enquiries in relation to funding for tree removal adjacent to electricity wires and she outlined how communities are being supported to apply for Community Climate grants. Dearbhala asked that the Councillors share the Climate Action Team Newsletter with their constituents and through their networks.

# 02 (25) Cllr. Stephanie Doheny

It was proposed by Cllr. Stephanie Doheny seconded by Cllr. Eugene McGuinness and agreed:

'That the Council affirms that every endeavour is made to ensure that Kilkenny County Council's tender processes are consistent with protecting international humanitarian law and prohibiting the importation or sale of goods or services originating in occupied territories.

This Council resolves to adopt a rights-based Ethical Procurement Policy (EPP) that takes fully into account existing obligations and standards. The primary aim of the EPP is to ensure that human rights obligations are properly acknowledged, observed and respected at all stages of the procurement process."

# 04 (25) Cllr. Eugene McGuinness

It was proposed by Cllr. Eugene McGuinness seconded by Cllr. Tomás Breathnach and agreed:

"To ask the Council to write to the Minister for Sport asking the Minister to clarify the Government current transgender policy particularly as it pertains to women's and girls' sport. We urge the Minister to engage in meaningful dialogue with female athletes, sports scientists and safeguarding experts to find the necessary wording and guidelines that respects both inclusion and fairness."

# 05 (25) Cllr. Maria Dollard

It was proposed by Cllr. Maria Dollard seconded by Cllr. Maurice Shortall and agreed:

"That Kilkenny County Council review its policy in calculating differential rents for its tenants and adopt the recommendation of Family Carers Ireland in their pre-budget submission 2024. The recommendations are as follows:

- *(i) Carer's Allowance will be disregarded at the basic Social Welfare rate in Kilkenny County Council Local Authority.*
- (ii) Half-rate Carer's Allowance will be disregarded in full in this Local Authority.
- (iii) Disability Allowance received by children aged between 16 and 18 years will be disregarded in full, in line with the existing uniform disregard of Domiciliary Care Allowance received by children under 16 years."

# 12. Fógraí i dtaobh Rúin ó Údaráis Áitiúla eile ag lorg tacaíochta ó Chomhairle Chontae Chill Chainnigh - Notices of Motion from other local authorities seeking support of Kilkenny County Council

It was proposed by Cllr. Fidelis Doherty, seconded by Cllr. Pat Dunphy and agreed that Notices of Motion 06 (25) to 12 (25) be taken as read and noted.

# 06 (25) Limerick County Council

"That, this Local Authority would call on the Government to put in place a financial support scheme within the grant aid for older people form to include people in medical need that they would be able to apply for financial aid to help them purchase a generator to allow them to power electric medical devices where loss of power occurs."

# 07 (25) Limerick County Council

"That, Limerick City and County Council expresses its fullest appreciation for all of the work done by the Council staff and staff of other agencies and volunteers who worked 24/7 to alleviate the hardships caused by the recent severe weather event. The Council now calls on the Minister for Housing, Local Government and Heritage to (a) immediately release funds to replenish Local Authority financial resources used to manage the emergency and (b) provide additional adequate funds (or otherwise provide financial arrangements) for Local Authorities impacted to arrange a local scheme to compensate homeowners and businesses for property damage, lost stock or foods or other reasonable uninsured damages caused by snowfall or electricity cuts, and that this Notice of Motion be circulated to all Local Authorities."

# 08 (25) Limerick County Council

"That, given the recent weather events, Limerick City and County Council (a) calls on Uisce Eireann to install generators at every pumping station in the country (b) calls on the ESB to cut back/ cut down all trees and/ or branches that are in danger of damaging the infrastructure and (c) calls on the Government to set up a special emergency phone number which is activated prior to and manned during all orange and red weather alerts."

# 09 (25) Roscommon County Council

"In light of over 40 trees falling during Storm Darragh, damaging power lines and leaving homes and businesses without power for days, I propose this Council writes to Nicholas Tarrant, MD of ESB Networks, and Keith Leonard, Head of the National Emergency Coordination Group. They should ensure compliance with wayleaves and exclusion zones near overhead powerlines, requiring forestry owners to meet clearance standards. ESB Networks should take pre- emptive measures ahead of storms to prevent similar outages. Additionally, compliance with the DAFM Standards for Felling & Restoration near public roads must be enforced to prevent road safety hazards during extreme weather. Subsequent to the submission of this motion the events of Storm Éowyn have further highlighted to need for action on this matter. It was agreed to circulate this motion to all Local Authorities."

# 10 (25) Roscommon County Council

"To write to the Department of Agriculture, Department of Transport, and Department of Environment, for an incentive to be put in place for landowners to move trees off the roadside. It was agreed to circulate this motion to all Local Authorities."

# 11 (25) Roscommon County Council

"To write to the Minister for Communications that all emergency frontline services have access to the GOV NE system to use any network available in the major emergency events to ensure communication channels remain open. It was also agreed to circulate this to all Local Authorities."

# 12 (25) Roscommon County Council

"To write to the next Minister for Education requesting the introduction of extra time for students with Dyslexia, Dyscalculia and other learning difficulties sitting second level examinations. The lack of extra time is a severe disadvantage to such students at this crucial time in their lives. It was also agreed to circulate this to all Local Authorities."
