Notice is hereby given, that at a meeting of the Council to be held after the expiration of 10 days from the date of this notice, it is the intention of Kilkenny County Council, in accordance with Section 183 of the Local Government Act, 2001, to dispose of its interest in a small plot of land at No. 1 Breaghagh Court, Kennyswell Road, Kilkenny (as identified on the attached map) to Christine and Neil Kavanagh, 1 Breaghagh Court, Kennyswell Road, Kilkenny for the nominal sum of $\[mathbb{e}$ 10 (ten euro) with each party responsible for their own legal costs associated with the sale. The site area measures 9 m². The Consent of the Minister for Housing, Local Government and Heritage is not required.


BACKGROUND

As part of Kilkenny County Council's Housing project in Crokers Hill an agreement was made with the owners of the property Christine and Neil Kavanagh at 1 Breaghagh Court to knock their boundary wall and in exchange to transfer a small portion of land to them in order to square off and tidy up an awkward notch in the footpath (see attached map). The land measures 9 m².
