RE: DISPOSAL OF INTEREST IN LAND AT CROWBALLY, MULLINAVAT, CO. KILKENNY

Notice is hereby given, that at a meeting of the Council to be held after the expiration of 10 days from the date of this notice, it is the intention of Kilkenny County Council, in accordance with Section 183 of the Local Government Act, 2001, to dispose of its interest in land at Crowbally, Mullinavat, Co. Kilkenny - as identified on the attached map - to Patrick Thomas Gaule, Crawn, Kilmacow, Co. Kilkenny for the sum of €1,000 with each party being responsible for their own legal costs associated with the sale. Plot areas combined measure 0.8 acre. The Consent of the Minister for Housing, Local Government and Heritage is not required.

BACKGROUND

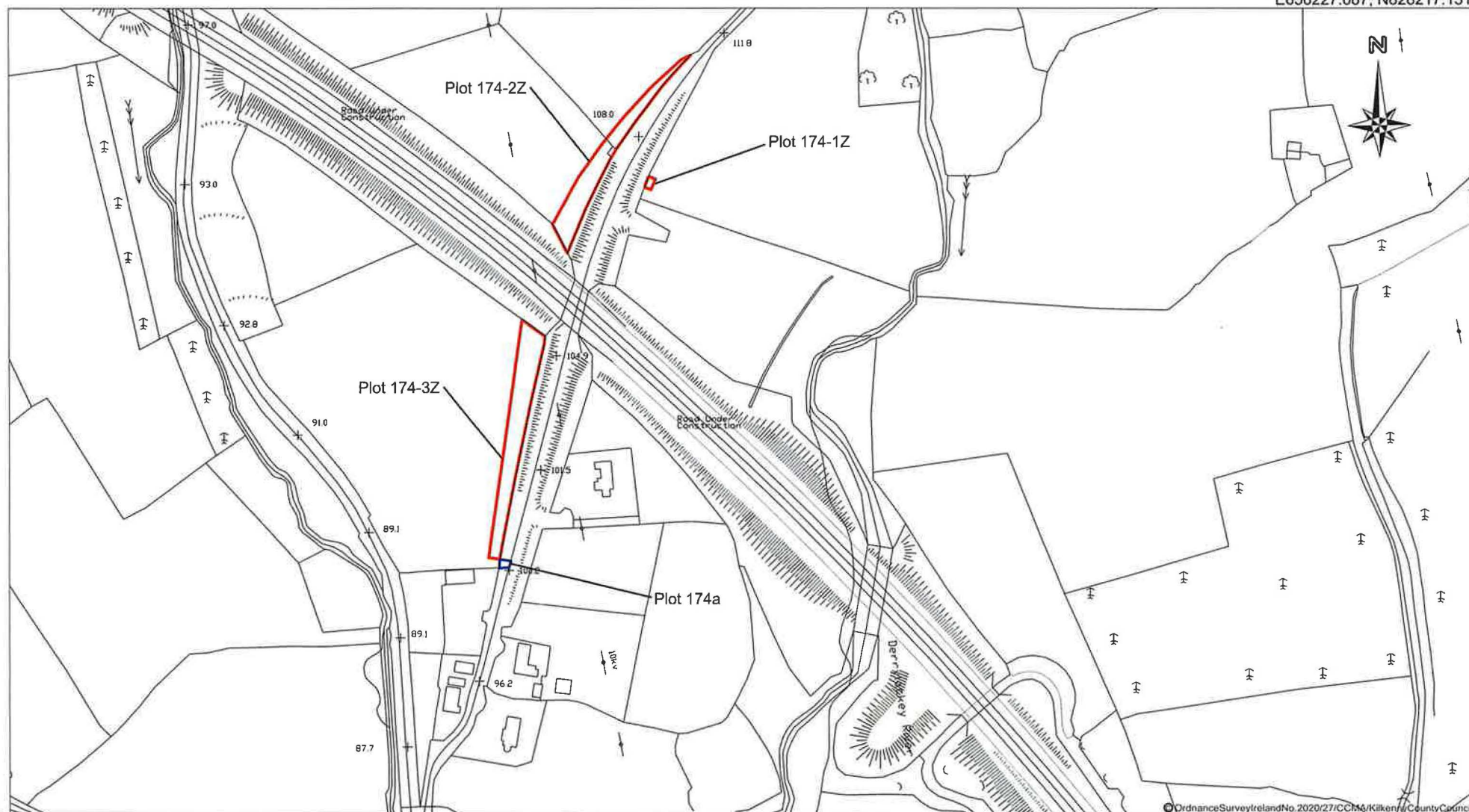
A Section 183 was approved by the Elected Member at the Meeting on the 21st February, 2022, however, the land is now transferred to Patrick Thomas Gaule, Crawn, Kilmacow, Co. Kilkenny, therefore, we need to rescind the original S183 and have another one approved. Plots 174-2Z and Plot 174-3Z were on the line of the old local road and were required for the realignment of the local road. The surplus area was subsequently fenced off with Ms. Gaule's fields. Plot 174-1Z was acquired for a recessed field gate that was not subsequently required. The landowner has agreed to transfer Plot 174a, which is a small area of existing roadbed, to Kilkenny County Council.
