2) Consideration of Reports and Recommendations

(a) Presentation on proposed Woodstock to South East Greenway Link by Aoife Quinn, RPS Consultants and Kieran Kelly, A/Senior Executive Engineer

Aoife Quinn, representing consultants RPS, presented the findings of a feasibility report, funded by Transport Infrastructure Ireland, on a proposed 20km greenway from Woodstock Gardens to the South East Greenway link at New Ross.

The greenway is envisaged as being fully segregated, safe, sustainable and attractive. It is envisaged as socially inclusive linking communities along its route and also to other amenities such as the Nore Valley walk, Cycle route etc. It should also increase tourism to Woodstock Gardens. It is proposed that impact on private lands will be limited. The project will be delivered in six phases subject to planning and funding:

Phase 1: Preliminary options will be examined and public consultations begun.

Phase 2: Option selection and route corridors, second public consultation and landowner consultation.

Phase 3: Design and Environmental impact study conducted.

Phase 4: Planning process.

Phase 5: Procurement

Phase 6: Construction.

Public consultation will begin on 10th February. A website will go live containing feedback forms. Leaflets will be distributed, ads in social media and posters displayed in public places. Two public meeting events will take place, firstly in Cois Abhainn and later further south of the county, location to be confirmed.

Cllrs expressed their thanks to Aoife for her presentation. They expressed general approval for the project and looked forward to the beginning of Phase 1.
