#### (a) Broadband update

Mr Steve Coverdale provided on update to members on broadband in the Castlecomer Municipal District as follows:

- All exchanges due to be completed by end of 2024
- Details of rollout status per Kilkenny Deployment Area as at December 2023 was provided
- NBI work ongoing 7,383 premises at 'available to order / pre-order' stage and 3,807 at 'network build in progress'
- Reminder of information available on NBI website
- Cellnex not proceeding with proposed mast location in Castlecomer as agreement had not been reached progress has now come to a standstill.
- Bank of Ireland, Urlingford are using a wireless solution

# 6. Correspondence

# (a) Constituency Boundary Change – North West Kilkenny

Cllr Mary Hilda Cavanagh spoke in relation to response dated 30<sup>th</sup> November received from Minister Malcolm Noonan's office on foot of request from the Castlecomer Municipal District that 'Kilkenny' would be incorporated in the title of the new North Tipperary constituency. Both Cllr Cavanagh and Cllr Michael McCarthy confirmed they accept the recommendations of the Constituency Commission but reiterated they want the name of the new constituency amended. Cllrs Cavanagh and McCarthy highlighted the precedent already in place. The number of constituents who have come forward and advised they will not vote in the next General Election was highlighted. It was agreed by all members that a further letter would be sent to Minister Malcolm Noonan's office requesting that 'Kilkenny' be incorporated in the new constituency title. Cllr Pat Fitzpatrick recommended that Kilkenny County Council run a public media campaign to advise constituents of the impact of this boundary change. Cllr Michael McCarthy requested a detailed map of the new North Tipperary constituency.

# (b) Public Lanes

Cllr Mary Hilda Cavanagh spoke regarding the MD's Community Involvement Scheme with in excess of 50 applications and despite a request to the Department no major funding has been received. Cllr Pat Fitzpatrick also spoke on this issue. It was agreed a letter would be sent to the Minister of Transport seeking additional funding.

Cllr Michael McCarthy spoke regarding damage caused to laneways by large trucks. It was agreed this issue would be dealt with at Director of Services level.
