1. Confirmation of Minutes of:

(a) January Ordinary Meeting held on 16th January 2023

The minutes were proposed by Cllr Michael McCarthy, seconded by Cllr Pat Fitzpatrick and agreed.

2. Consideration of Reports and Recommendations:

(a) Broadband – update

Mr Steve Coverdale updated the members on progress of the Broadband project in North Kilkenny.

- Johnstown Active – 1000 premises passed
- Castlecomer CPO complete. Full Council to vote for lease of site to NBI in Feb meeting. NBI due complete site by Aug 23
- There are multiple villages with poor broadband that are outside the NBP. There will be fibre available in these areas by the end of the NBP in 2026/2027.

Members thanked Mr Coverdale for the work completed. It was agreed that the members would receive an update on the Broadband project every 3 months.

i Report on waste water problem at Council Houses at Canal Road, Johnstown

Mr Philippe Beubry confirmed the blockage has been cleared. Council are liaising with Irish Water in relation to carrying out survey works in the public area.

ii Provision of rumble strips at roundabout on Grangefertagh Lane to prevent doughnuts on the roundabout by joy riders.

Mr. Philippe Beubry acknowledged the issue. However, this is not unique to this road. It is a matter for the An Garda Síochána to police. The provision of rumble strips will not prevent joy riders and will set a precedent to provide rumble strips in other areas.

Cllr Mary Hilda Cavanagh felt that there was an increased risk in the area due to its proximity to a busy motorway. She asked that an engineering solution be investigated.

Cllr Pat Fitzpatrick agreed to raise issue at next Joint Policing Committee meeting.
