(a) 2024 Road Works Scheme update

Mr Philippe Beubry provided an update on the delivery of the 2024 Road Works Scheme under the following headings:

Mr Beubry confirmed a supplementary grant in the amount of €319,317 was allocated to the Castlecomer MD under Circular RW 09 of 2024 from the Department of Transport and provided a breakdown of proposed works and budget for each GSS area. The additional restoration improvement works as outlined were proposed by Cllr Pat Fitzpatrick, seconded by Cllr Mary Hilda Cavanagh and agreed.

(b) Paulstown & Ballyragget Masterplans

Ms Arlene O'Connor provided a brief update on both the Paulstown and Ballyragget Masterplans wherein she provided details on public display periods, public information sessions, submissions received, main issues raised in submissions and the next steps.

(c) Review of the Castlecomer Local Area Plan 2018

Ms Catriona O'Sullivan provided an update to members on the review of the Castlecomer Local Area Plan 2018-2024. Ms O'Sullivan confirmed that owing to changes in the Planning Act, the statutory plan will be passed by members as a variation of the City & County Development Plan. She confirmed the pre-draft stage is about to commence with publication of an Issues Paper and Health Check survey; Ms O'Sullivan also provided details on the next steps and a list of stakeholders.

(a) Cllr Mary Hilda Cavanagh

i Community Involvement and Local Improvement Schemes

Cllr Mary Hilda Cavanagh requested that the terms conditions of both these schemes be made available for the next meeting. She spoke of applicants who had previously benefited from the Community Involvement Scheme who were unaware of the need to reapply for the scheme. Members spoke of insufficient funding for the Community Involvement Scheme with 48 applications included on the current list of applications and funding available to complete only 3 schemes in the current year.

Cllr Cavanagh also spoke regarding the Local Improvement Scheme and advised the scheme had recently been raised in the Senate and Minister Ossian Smith had referred to the discretion of Local Authorities in making decisions of which she was unaware. Cllr Cavanagh requested and was supported by the members that a letter issue to the Department seeking clarification on this issue.

(b) Cllr Maurice Shortall

- Safety concern at The Square, Castlecomer from the Ballyragget side
 It was agreed ClIr Shortall would deal directly with Mr Philippe Beubry on this issue.
- ii Update / provision of wheelchair accessibility for Oak Hill / Acorns Estate, Castlecomer It was agreed Cllr Shortall would deal directly with Mr Philippe Beubry on this issue.
- iii Update on the Clogh / Castlecomer / Moneenroe ongoing water problems and the implementation of a plan with Irish Water if one is not already in place to keep the public updated on this issue.
