"That this Municipal District would investigate the provision of wheelchair friendly swings and amusements in playgrounds in Kilkenny and also to enter into discussions with the O.P.W. with a view to providing wheelchair accessible amusements in the play area at Kilkenny Castle Park. Should this be successful, the provision of such equipment should be rolled out across the city and county."

"That Kilkenny Municipal District Council would develop a plan for the conservation, restoration and maintenance of historic plaques, Mayoral plaques, cast iron street name signs, memorial stones and other wall mounted and freestanding commemoration features within the functional area. Within such a plan consideration should be given to the replacement over time of modern street name signs within the Architectural Conservation Areas (ACA's) of Kilkenny City with replica cast iron street signs in Irish and English languages."

“That this Municipal Council calls on Kilkenny Local Authority to reopen discussion regarding the lighting situation on the Kilkenny side of Bennettsbridge and on the bridge itself. This has been talked about for a number of years and action is now required as monies had originally been ring fenced from the old Callan and Thomastown Electoral Areas for this project.”

"That monies left aside by the former Borough Council for the provision of a skatepark in Kilkenny City be ring fenced for the provision of such a facility on the Brewery Site, that a committee including skateboarders be set up immediately in order to agree a design for the facility and that a time frame be put on the project to keep people informed of its progress."

Notice of Motion in the name of Cllr. Peter ‘Chap’ Cleere received 3rd December, 2015:**

“That Kilkenny Municipal District Council would prepare a report outlining details of the costs involved to erect new public lighting throughout the area. There should be full Consultation with all councillors who should forward on details of areas where public lighting is inadequate - this should be surveyed and prioritised. Following this, sufficient financial provisions should be set aside in municipal budget next year and an ongoing plan be put in place to ensure a new schedule of works can be both put in place and achieved.”

Such a committee will inform the Municipal Advisory Committee on best practice and policy related to the Architectural Conservation Areas (ACA’s) of Kilkenny City and advance the enhancement of the Medieval Mile experience by exploring opportunities for representing and identifying the remaining Renaissance Town Houses and medieval houses on its route, conserving and enhancing vernacular building features and stock and other initiatives that will promote the awareness of Kilkenny’s significance as a medieval town.”
