Notice of Motion in the name of Cllr. Malcolm Noonan received 3<sup>rd</sup> May, 2016:**

"That members of Kilkenny Municipal District Council request Kilkenny County Council to consider the introduction of a single speed limit consistent with speed limits on connecting sections of road at the N79 road in its review of speed limits in the County. This would require the reduction in the speed limit between Shellumsrath to Tennypark from 80kmph to 60kmph in order to improve general road safety in the area. This motion recognises that the guidelines on consistency in speed limits for National Roads is fundamentally flawed in this case as it fails to recognise (a) this section of road contains a substantial number of residential developments and (b) reducing the speed limit will configure speeds with connecting sections of road in this area."

Notice of Motion in the name of Cllr. David Fitzgerald received 13<sup>th</sup> May, 2016:**

That Kilkenny Municipal District prepare a plan for the refurbishment of "The Village" area of Kilkenny City to include Upper Patrick Street, New Street and Jacob Street to create a citizen friendly zone which includes a Traffic Management Plan and the renewal of the paved surfaces, landscaping and public seating.
