## 1. Minutes of previous meeting and Matters Arising

The Minutes of previous meeting of SPC 2 held on the 9<sup>th</sup> December, 2022 were adopted.

Proposed by Cllr. Michael Delaney and seconded by Cllr Pat Dunphy.

## 2. Capital Roads Projects incl. N24 & N25

Seamus Kavanagh presented on the Capital Roads Projects as follows:

- N 25 Waterford to Glenmore, to improve approximately 9.5 km of the N 25. Stage 2 was complete and a 600m corridor selected. No funding allocation for this scheme in 2022.
- N 24 Waterford to Cahir, to improve approximately 60km. Stage 2 options report ready for public display which would be followed by a preferred corridor. No funding allocation for this scheme in 2022.
- N 24 Tower Road Safety Scheme. €3m allocation, construction stage Q3/Q4 this year,
- North/South Link Road. Ferrybank Area, to link up Old N24 to Abbey Road. 75% funding URDF, 25% funding from Council own funds.
- Kilkenny North Ring Road extension, 1.5 km in length. Currently a SARS report due Q1 2022.

- CBS Link Road, Kilkenny County Council did a Part 8, this has received Part 8 planning permission. An Bord Pleanala confirmed decision of Kilkenny County Council that a Stage 2 AA was not required. it is gone to tender today, aim to have Consultants on site by Q 3 this year.
- Breagagh Valley, Link Road Design, estimated cost €3m if built, it would free up traffic the area and open up for Active Travel, walking and cycling.

# 3. National Road Safety Strategy

Tim Butler gave a detailed presentation on the Governments National Road Safety Strategy 2021 – 2030 outlining the following:

- Journey towards Vision Zero 7 Safe Systems priority interventions
- Targets
- Phased Approach
- Phase 1 Action Plan 2021 -2024
  - o High-impact actions (50)
  - o Support Action (136)
- Examples of Key Action:
  - o Safe Roads & Roadsides
  - Safe Speeds
  - Safe vehicles
  - Safe Road Use
  - o Post Crash Response
  - Safe & Healthy Modes of Transport
  - o Safe Work related Road Use

Tim Butler advised that a smaller Working Group would be set-up and would report back to the SPC on same.

Cllr. T Breathnach noted there are different degrees of vulnerable road users. Cllr. T Breathnach also noted that Ireland had the second lowest fatalities in Europe in 2019 per capita and requested if we could get up to date fatality figures in comparison to UK, Norway & Sweden.

### 4. Update Speed Limit Review

Cllr. Matt Doran welcomed Joe Scully to the meeting. He gave a presentation outlining the update on the Speed Limit review.

Kilkenny County Council to

- prepare public consultation maps
- commence speed limit review public consultation process in April 2022

- roads department to assess public speed limit change submissions/objections
- Municipal District Elected Members to consider report of public submissions/objections at June Municipal District meetings
- Prepare draft B speed limit bye-laws and maps in July 2022
- Proposed adoption of speed limit changes at September 2022 meeting of Kilkenny Council

## 5. Water Capital Projects

Seamus Kavanagh presented on the Water Capital projects. Kilkenny County Council manages 23 public drinking water supplies and 36 public waste water treatment schemes on behalf of Irish Water. This serves 67,500 customers, using 28.5 million litres of water a day approximately, at a cost of €9.2m. Mains replacement 2022:

- Knocktopher Village 1,250m (in progress)
- Knockanore Cross to Norelands WTP + rising main to Rathduff Reservoir-4,600m
- o Carrickmourne, Thomastown 3,250m
- o Slieverue Village 1,050m
- o Dublin Rd, Thomastown 750m
- Michael St, Kilkenny 450m
   Design
- o Norelands Bridge (Knocklynon Bridge) circa 85m.

#### Town and Village Growth Programme:

o Bennettsbridge was selected in Kilkenny for a full waste water upgrade as part of the plan. The amount committed for Kilkenny under the programme is €5m and the Council are working with Irish Water to ensure the project is delivered on time.

Cllr. Matt Doran thanked Seamus Kavanagh for the details. Cllr. Pat Dunphy queried how are we going to get around leakage issue, on a regular basis around the county. Some of those roads on the programme and Irish Water do not appear to be delivering.

Seamus Kavanagh advised the list of roads in presentation are the worst in Kilkenny at the moment. We will look at areas with the Area Engineers. There is a road opening process where the road has to be resurfaced....

## 7. Broadband Rollout

Tim Butler gave an update on the current work underway by National Broadband Ireland and the engagement with Area Engineers and the Planning section.

Section 254 licences to deal with Broadband have been carried out at South Glenmore, Piltown, north of the county and the Carlow side and all infrastructure should be done in these areas by year end.

Cllr T Breathnach asked if Broadband Ireland could be invited back again and noted it is important to keep this on the agenda.

Cllr P Dunphy raised the issue that the broadband in the areas of Mooncoin for example is very weak, most of those villages are worst served – advised that this was an issue for Eir.

Gerard Ferris advised on the N78 he has fibre to his house but the town itself doesn't seem to have coverage, if that could be extended.
