Privacy Statement

Please read the following information relating to the collection and use of your personal data and the declaration carefully. You should only consent to completing the community survey on health needs if you are entirely satisfied that you understand all of the information presented in this form.

Who we are and why do we require your information?

Kilkenny County Council is the democratically elected organisation whose principal function is to provide a broad range of services in areas such as Housing, Roads & Transportation, Flood Prevention, Water Services, Economic Development & Tourism, Planning & Conservation, Environmental Protection, Heritage & the Arts, Library Services, Community & Culture, Amenity, Sport & Recreation, Fire Services, Energy, Older People & Age Friendly, Children & Younger People, Financial Management & Customer Services development. The Healthy Ireland Fund is managed and administered by Pobal on behalf of the Department of Health. Kilkenny Local Community Development Committee (LCDC) provides oversight and management of the delivery of the Healthy Ireland Fund on behalf of Kilkenny County Council. The Purpose of the Healthy Ireland Fund is to promote and support the Health and Wellbeing of Kilkenny. The Kilkenny LCDC works to improve health and wellbeing by creating and improving the physical and social environment and developing community resources that help people support each other.

In performing its functions, Kilkenny County Council is required to collect and process significant amounts of "personal data" within the meaning of the General Data Protection Regulations [GDPR] and of the Data Protection Acts 1988 to 2018. The Council respects the privacy rights of those whose personal data we process and we are conscious of our obligations under the Data Protection Acts.

The purpose of this Privacy Notice for the Healthy Kilkenny Team is to outline in clear and concise terms the personal data that we may collect about individuals while carrying out this survey. Why it is required and how long the information is retained. It also outlines the rights of individuals under data protection legislation in relation to the processing of their personal data.

The survey is being conducted to give the Council more accurate information on the health needs in the Eastern Environs of Kilkenny City. This information will help the Healthy Kilkenny Committee and Kilkenny Local Community Development Committee make decisions on health and wellbeing projects to respond to the health needs of people living in the Eastern Environs

Why do we have a privacy statement?

Kilkenny County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with the Community Department of Kilkenny County Council that we will ensure the security of the data you provide to us.

Kilkenny County Council collects and processes a significant amount of personal data in various multiple formats on a daily basis. Kilkenny County Council's commitment to you is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

Data protection Policy

Kilkenny County Council has a detailed <u>Data Protection Policy</u> which goes into more detail on how we as a public body are committed to ensuring the security of any personal data you provide to us.

What personal or sensitive data do we need?

No personal data that identifies you will be asked i.e. name, email, address. The types of personal/sensitive data you may be asked to supply can be categorised as follows:

- IP Address
- Street Name or Neighbourhood in the eastern Environs (drop-down)
- Age Bracket
- Gender
- Ethnic Origin
- Health Status: self-perceived health and subjective measures
- Health behaviours smoking, healthy eating, physical activity
- Disability or Life limiting illnesses e.g. to understand any health needs

Sharing Information

The Council may share your information internally (within the Council) in accordance with statutory obligations. In addition, the Council may share your information with third parties in accordance

with statutory and regulatory obligations. Where this is required the Council shall have regard to the security and integrity of the data and will minimise the data shared.

Third parties that we may share this information with may include some of the following:

- Appointed Project consultants
- Kilkenny County Council will share anonymised data with Kilkenny Local Community

 Development Committee, Pobal and Department of health who are contracted with Kilkenny County

 Council to administer the Healthy Ireland Fund at a local level

Legal and Regulatory Obligations

Legal Basis for collecting, retaining and processing personal and non-personal data Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in Kilkenny County Council in accordance with Article 6(1)(a) (e)and Article 9(2)(a) (i) of the General Data Protection Regulation, 2016. Specifically, the lawful basis for this process is contained in:

- Section 66 3 (a & b); 67.1 and 67.2 of the 2001 Local Government Act
- Section 36 of the 2014 Local Government Reform Act: Local Community Development Committees

When we rely on your explicit consent to process personal data, you retain the right to withdraw that consent at any time. However, please note that this survey does not intended to collect information that could personally identify you, such as your name, address, or contact details. As a result, Kilkenny County Council may not be able to identify you individually to remove your data once the survey has been submitted

Records Retention Policy

Kilkenny County Council practices in relation to the retention of personal data are guided by the Local Government Management Agency's (LGMA) National Retention Policy for Local Authority Records and any updates that are issued by the LGMA. Copies of these documents are available here

The retention period in this case will be **eight years** after the project commences.

Your Data Protection Rights

Your Rights: You have rights in respect of your data that we are processing as part of the Healthy Ireland Fund, These rights include the following:

- The right to access a copy of your personal data
- The right to rectification
- The right to erasure
- The right to restriction of processing
- The right to data portability

- The right to object processing
- The right to withdraw consent
- The right to lodge a complaint with the Irish Data Protection Commission
