Local Enhancement Programme 2024

Anne Marie updated the LCDC members on the Local Enhancement programme for 2024. The total allocation comprises of €151,822 made up of €126,519.02 capital funding with 30% ring-fenced for grants of €1,000 or less and €25,303 capital funding ring-fenced for Women's groups.

Small scale project applications accepted for grants of up to €1,000, medium scale applications for grants between €1,000-€5,000. There will be a limited number of larger grants considered for larger projects if they satisfy the eligibility criteria and the scheme

Application form and guidelines are available for download from Kilkenny County Council website www.kilkennycoco.ie or contact any member of the Community Department. Closing date is Friday 16th of February, with final approval at the March LCDC meeting.

Items for discussion and decision

CDP Subgroup Members

Katherine Peacock provided a report to the members from the CDP subgroup. The Community Development Programme is a pilot programme offering funding support to KTCM (Kilkenny Traveller Community Movement). The project is currently experiencing a high turnover of staff and this may lead to changes in the project.

The subgroup has lost 3 of its members, Sean McKeown, Sheila Donnelly and Declan Gibbons, and we now wish to replace these members. Current members on the subgroup include Katherine Peacock, Anne Marie Shortall and Paul O' Rahilly. There are usually 3-4 meetings a year but possibly additional meetings this year due to current circumstances.

Night Time Economy

Aileen advised in 2023 Kilkenny was selected as one of 9 pilot areas for funding from the Department to deliver an action plan on the Night Time Economy for Kilkenny City.

Conor Sweeney now appointed as the Night Time Economy Advisor. There are 2 surveys live on consultkilkenny.ie until mid-February. Aileen will circulate link to the committee and Conor is available for one to one consultation or if any organisation would like to get in touch to meet with Conor.

Paul O' Rahilly noted Kilkenny Access Group had a very positive meeting with Conor which they brought some of their issues to the meeting, and Kilkenny Chamber have also been in touch with Conor they are linking in. Ossory youth will also contact Conor.

Derval noted that the HSE have linked in with Conor and Derval will also circulate the survey link to Kilkenny based HSE staff.

Careers Kilkenny 2024

Aileen updated the meeting on Careers Kilkenny 2024 which is due to take place in Kilkenny on Saturday 3rd of February, in St. Canices Cathedral commencing at 10: 00a.m. There will be over 30 stands in place with a large range of employers, all promoting Kilkenny as a great place to live and work.
