# 2. Items for discussion and decision

Presentation Martin Rafter SICAP Annual Plan 2024.

Michael Fitzgerald had a query on the impact of immigration and high level of publicity surrounding it.

Martin updated the members how the response to immigration in Kilkenny ensured people got involved in social and cultural activities, and explained that the arrival of Ukrainians is low compared to what they were. The ETB provided language supports and the HSE provided health supports, with significant effort from all agencies.

# 4. Items for Information and Information Sharing Update on KTCM Management Committee Katherine Peacock provided an update to the members on the KTCM Management Committee.

In March new members were sought to join the committee and a new board of 9 members has now been established.

The first meeting of the new board took place on the 9<sup>th</sup> of April and was externally facilitated by Workhouse Union. In the interim they have advertised for a new project manager, closing date of 13<sup>th</sup> of May, 2024. Once the new project manager is in place recruitment will follow for a development worker. Further update to be provided at next meeting.

Derval and Angela thanked Katherine for the update. Katherine advised that 3 of the previous board members remain on the board.

# **Community Recognition Fund**

Anne Marie Shortall informed the members of the Community Recognition Fund and the consultation process involved. The fund aims to support the development of community infrastructures and facilities to recognise the contribution made by communities for welcoming significant numbers of new arrivals from Ukraine and other Countries. This year Kilkenny were allocated €868,000 with 20% of this fund being reserved for new arrivals expected later in the year. The type of projects to be funded will be capital projects and are to be delivered over the next 2 years.

The Department set out certain criteria on how the grant is to be allocated which includes the number of arrivals in each area of the county. The closing date for expressions of interest for this fund was the 10<sup>th</sup> of May, 2024. The fund applications were managed and assisted by Community Section staff. The Evaluation committee will decide the most suitable projects and follow an evaluation process. Based on the number of arrivals there was particular focus on the following areas:- Kilkenny City, Thomastown, Bennettsbridge, Knocktopher, Freshford, Ballyragget and Castlecomer. These areas were highlighted in the advertisement for the fund.
