**Proposed Southern Slip Roads at Cashel Junction Compulsory**  
**Purchase Order (No. 1), 2006**

The Kilkenny County Council (hereinafter referred to as "the local authority") in exercise of the powers conferred upon them by section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by section 10 of the Local Government (No. 2) Act, 1960 as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Act, 2000 have, on behalf of South Tipperary County Council in pursuance of an agreement made under Section 59 of the Local Government Act 1955 and approved by the National Roads Authority under Section 14(8) of the Roads Act 1993, made an order entitled as above which is about to be submitted to An Bord Pleanála for confirmation. If confirmed, the order will authorise the local authority to acquire compulsorily the land described in the Schedule hereto for the purposes of the construction of the proposed Southern Slip Roads at Cashel Junction.

Owners, lessees and occupiers of the land described in the Schedule Part 1 will receive individual written notice.

The Board cannot confirm—

(a) a compulsory purchase order in respect of the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and not withdrawn,

until it has caused to be held an oral hearing into the matter and until it has considered the objection and the report of the person who held the oral hearing.
